

Taste of Country Buffalo Thomas Rhett Meet and Greet Giveaway  
Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Taste of Country Buffalo Thomas Rhett Meet and Greet Giveaway (the “Promotion”) is open only to legal residents of the fifty (50) United States (including District of Columbia) who are eighteen (18) years or older at the time of entry. Void in Guam, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees of Townsquare Media Inc., or any of its respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Promotion and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. 3. Timing

4. How to Enter:

There is one (1) way to enter the Promotion. Limit one entry per person regardless of entry method. To enter you must complete the following Options during the Promotion Period:

Option 1: You will automatically be entered into the Promotion by texting “JJCASA” to 24587 each day of the Promotion Period. You must choose to join our Text Alert Club to complete your entry by replying to the text messaging asking confirmation to join. Entries will be selected from only those text messages to the specific phone number provided (24587), at the time texting is solicited, shall be eligible to win

5. Winner Selection

All eligible entries received during the Promotion Period will be entered into a Prize Draw. On or about March 6th, Sponsor will select in a random drawing of all valid entries received one (1) winning entries. ## 6. Winner Notification

Industry, press, and complimentary tickets are not eligible for Prize. No cash equivalent for the prizes, prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. ## 9. Verification of Potential Winner

The potential winners will be notified by text message or email, after the date of random drawing. The potential winners may be required to sign and return to Sponsor, within ten (10) days of the date notice is sent, an affidavit of eligibility, and liability/publicity release (except where prohibited) in order to claim his/her prize if applicable. If a potential winner of any prize cannot be contacted, fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, postage due, unintelligible or misdirected entries, which will be disqualified. Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor’s reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. reserves the right to contact entrants and all other individuals whose phone number is submitted as part of this promotion.
