Jordan Kilby, Deputy County Attorney of Missoula County, Montana, being first

duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of D# for allegedly committing the offenses set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.

On or about October 20, 2012, Missoula City Police Officers responded to the Sigma Nu Fraternity House in Missoula County for a report of a physical disturbance. Officer Manraksa arrived and took statements from the victims. Nicholas Connor (Connor) stated earlier that evening two males arrived and wanted to enter the fraternity. He informed the males he would not let them inside and that they needed to leave the property. He advised the males that they were not welcome there.

Later in the evening, the two males returned and were accompanied by two other males. They knocked on the door and as soon as Connor opened the door, they pushed by him and stated "Remember us motherfucker?" All four pushed their way into the fraternity. They then started punching Connor and others inside the residence. The males assaulted at least three other people in the group.

Paul Springer (Springer), who was bleeding from the nose, described that the two males had fled westbound from the location towards Higgins. Officer Manraksa received descriptions of the two males who had arrived at the house earlier and then come back again. He provided the description of the suspects to other officers in the area. Officer Puddy advised that he had possibly located the suspect males nearby and Officer Manraksa transported Conner to that area to see if Conner could identify anyone. Prior to arriving at the location, Connor stated that one of the males should have a bloody nose.

Upon arrival, Connor identified the two males as the two males who had arrived at the fraternity earlier in the evening, had been denied entry and then came back later and assaulted him and others. They were Marc Cooper (Cooper) and Patrick Sobba. Cooper was bleeding from the nose. Both males claimed they were at the residence, but that they had been "jumped."

Officers had also located another male, Parker Munsey (Munsey), who Conner identified as one of the males who returned with Sobba and Cooper. Conner also stated there was a fourth male, but that he was unable to provide a description.

Officer Manraksa spoke with Munsey who stated he had left a party at Sigma Nu when Sobba and Cooper were denied entry. He stated he later returned with them and

observed Cooper and Sobba force their way into the fraternity and begin assaulting people inside. Munsey stated he threw some punches, but was trying to separate people. Officer Manraksa spoke with other witnesses who stated Munsey was also involved, but he was more of a "lookout" than the main aggressor.
