JORDAN KILBY, Deputy Missoula County Attorney, being duly sworn,
deposes and says that on or about the 20th day of October, 2012, at Missoula
County, the above-named Defendant committed the offense(s) of **COUNT I:**
SEXUAL INTERCOURSE WITHOUT CONSENT, a Felony, in violation of
Montana law, namely: Mont. Code Ann. §45-5-503, punishable by no less than 2-4
years or more than 100 years or life MSP and \$50,000 fine; **COUNT II:**
ENDANGERING WELFARE OF CHILDREN - 1ST OFFENSE, a Misdemeanor,
in violation of Montana law, namely: Mont. Code Ann. §45-5-622(1)[1st],
punishable by 6 months MCDP and/or \$500 fine.

The facts constituting the offense(s) are:

COUNT I:


On or about the 20th day of October, 2012, the above-named Defendant
knowingly had sexual intercourse with Jane Doe without consent.

COUNT II:

On or about the 20th day of October, 2012, the above-named Defendant
knowingly endangered the welfare of Jane Doe, a child under 18 years of age,

by violating a duty of care, protection or support to such child, to wit: provided Jane Doe with alcohol. The Defendant was supervising such child at the time of the offense.


JORDAN KILBY, Deputy County Attorney of Missoula County, Montana,
being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of
SEAN TIMOTHY QUINLAN for allegedly committing the offense(s) set forth in the
complaint and based upon the information contained in the reports, if true, believe
probable cause exists to justify charging the above-named defendant as specified
in the accompanying complaint.

Jane Doe, (Doe) reported that on or about 20th day of October, 2012 Sean
Quinlan (Quinlan), age 31, picked up Doe, age 13, from her house. He took her
to the Holiday Station and bought her Mike's Hard Lemonade (which is an
alcoholic beverage). He took her back to his house where she drank 10 drinks
and he reported he had "more than you can count." Doe reported Quinlan was

drinking Pabst Blue Ribbon. The two fell asleep on Quinlan's bed and at 9:00 am, Doe woke up. Although she had gone to sleep with her underwear and pants on, she was naked from the waste down. Quinlan was penetrating her with his finger. His penis was erect. He texted her several times over the past couple of days, stating things like he was sorry, he was going to get help and he messed up.

When detectives interviewed Quinlan, he stated that he had a lot to drink, that Doe is an honest person and that if she said something happened she would be telling the truth. When asked if he had sexual intercourse with Doe, he stated, "Anything is possible." Detectives searched Quinlan's residence and found four empty bottles on Mike's Hard Lemonade and an empty can of Pabst Blue Ribbon beer.
