JENNIFER CLARK, Deputy Missoula County Attorney, being duly sworn, deposes and says that on or about the 23rd day of November, 2012, at Missoula County, the above-named Defendant committed the offense(s) of COUNT I: CRIMINAL MISCHIEF, a Felony, in violation of Montana law, namely: Mont. Code Ann. §45-6-101(1)[2], punishable by 10 years MSP and/or \$50,000 fine; COUNT II: CRIMINAL ENDANGERMENT, a Felony, in violation of Montana law, namely: Mont. Code Ann. §45-5-207, punishable by 10 years MSP and/or \$50,000 fine; COUNT III: FLEEING FROM OR ELUDING A PEACE OFFICER, a High Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. §61-8-316(2)(a), punishable by 1 year MCJ and/or \$2,000 fine.

The facts constituting the offense(s) are:

COUNT I: On or about the 23rd day of November, 2012, the abovenamed Defendant committed the offense of criminal mischief by knowingly or purposely damaging a Mustang, the property of Shawn Golie, without consent by puncturing a tire, writing on it with a permanent marker and running her car into the side of the Mustang. COUNT II: On or about the 23rd day of November, 2012, the abovenamed Defendant knowingly engaged in conduct that created a substantial risk of death or serious bodily injury to Shawna Golie, by driving her car into Golie's car while Golie was standing next to it.

COUNT III: On or about the 23rd day of November, 2012, the abovenamed Defendant, while operating a motor vehicle fled from or eluded a
uniformed peace officer, Officer Vreeland, operating a police vehicle in the lawful
performance of such officer's duties who gave the Defendant a visual or audible
signal by hand, voice, emergency light or siren directing the Defendant to stop
the motor vehicle and such Defendant knowingly failed to obey such signal by
failing to stop when signaled.

AFFIDAVIT OF PROBABLE CAUSE

JENNIFER CLARK, Deputy County Attorney of Missoula County, Montana, being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of CYNTHIA R EVERS for allegedly committing the offense(s) set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.

On November 23, 2012, at approximately 11:30 a.m., Missoula City

Police Officers were dispatched to the C'Mon Inn at 2775 Expo Parkway for a
report of a disturbance. Detective Stacy Lear interviewed the complainant,

Shawna Golie. Golie stated she had spent the night at the hotel with her friend

Joshua Jordan, but that when she arrived Jordan had another female, identified

as Cynthia Evers, staying with him. Jordan and Evers had a disagreement during the night after which Jordan locked Evers out of the room

The next morning, Golie left the room and was loading her luggage into the trunk of her silver 2005 Mustang coupe when she discovered her rear driver's side tire had been punctured. While Golie was still standing at the trunk, she was approached by Evers, who admitted to Golie that she had punctured the tire. Golie then told Evers she was calling 911.

Evers then left on foot. A short time later Golie saw Evers driving toward her in Evers' white Suzuki SUV. It appeared to Golie that Evers was intentionally trying to run over her. Golie leapt aside and was not hit, but Evers sideswiped the rear of Golie's Mustang, causing significant damage. Golie stated she was standing by the trunk with luggage at her feet when Evers drove at her, and that Evers also hit a piece of her luggage and dragged it from the scene under her SUV. Golie also stated Evers was trying to hit her and that if she had not moved out of the way she would have been struck. After Evers left the scene, Golie discovered someone had written "punk" and "run rabbit run" on her vehicle in black permanent marker.

Officers located Evers driving on I-90 and were able to stop her after a brief pursuit. Detective Lear interviewed Evers. Evers admitted to puncturing Golie's tire with an army green-handled fixed blade knife, and also admitted to writing "punk" and "run rabbit run" on Golie's car with a Sharpie permanent marker, which she placed in her own vehicle after the vandalism. Evers also admitted to intentionally ramming Golie's car with her own vehicle, and said she

had also run over a piece of luggage and dragged it under her car for some distance before stopping, removing it, and placing it inside her vehicle. Evers claimed she did not see Golie standing near the vehicle when she hit it.

The estimated damage to Golie's vehicle is over \$1,500.00.
