JORDAN KILBY, Deputy Missoula County Attorney, deposes and says that on or about and between the 24th day of December, 2012, and the 25th day of December, 2012, the Defendant committed the offense(s) of COUNT I: ASSAULT WITH WEAPON, a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-213, punishable by 20 years MSP and/or \$50,000 fine; COUNT II: RECKLESS DRIVING, a Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. 61-8-301(1)(a), punishable by 90 days MCDF and/or \$25-\$300 fine;


The facts constituting the offenses are as follows:

COUNT I: On or about the 25th day of December, 2012, the above-named Defendant purposely or knowingly caused reasonable apprehension of serious bodily injury by use of a weapon by ramming

1 Edward Murphy's vehicle with his own vehicle and trying to run Murphy off  
2 of the road.

4 COUNT II: On or about the 25th day of December, 2012, the above-  
5 named defendant operated a vehicle in willful or wanton disregard for  
6 people and property when he drove erratically, ran his vehicle off the road,  
7 and damaged fence posts.

25 On or about the 25th day of December, 2012, Missoula County  
26 Sheriff's Deputies responded to the Huson area in Missoula County,  
27 Montana for the report of an assault currently in progress. Edward Murphy


1 called dispatch and reported he was being chased in his vehicle by  
2 Nathaniel Webb, who was in a Jeep Cherokee. Murphy advised that Webb  
3 was ramming the back of Murphy's vehicle and trying to pass him. Murphy  
4 was driving a 1972 truck, pulling a large Airstream camper. Deputies  
5 arrived on the scene and documented significant damage to the front  
6 bumper of Webb's vehicle. On Murphy's camper, there were scratches and  
7 dents, which seemed to be caused by being struck by the Jeep.  
8

10  
11 Murphy stated that he met Webb on Craigslist a few days earlier and  
12 agreed to rent trailer space from Webb. Murphy noticed that Webb had  
13 been acting odd lately and Murphy decided to leave. As he pulled out of  
14 the residence, Webb got in his Jeep and began to follow him. Webb  
15 rammed the back of Murphy's camper and tried to pass him in what was an  
16 attempt to run Murphy off of the road. Murphy was afraid for his life,  
17 believed that Webb was trying to kill him, and thought he was going to be  
18 killed by being run off of the road.

20  
21

22 Deputy Pavalone located the area where Murphy reported Webb tried  
23 to run him off the road. She observed that the area was disrupted where a  
24 vehicle veered off the road and knocked down three fence posts.  
25

26  
27 Sergeant Rio reported that when he arrived on the scene, he noticed  
28 a vehicle pulling an Airstream trailer and he saw, what was later identified

1 as Webb's Jeep Cherokee attempt to illegally pass the other vehicle.  
2  
3 Sergaent Rio stopped the Jeep Cherokee. When Deputies approached  
4 Webb's vehicle, they struggled to get Webb to comply with their orders.  
5  
6 Sergeant Rio walked up to the passenger side of Webb's vehicle and  
7 ordered Webb to get out of the vehicle. Sergeant Rio observed Webb had  
8 what looked like a large knife between his right leg and the center console.  
9  
10 Sergeant Rio observed Webb reach down toward the handle of the knife.  
11  
12 Deputies ordered Webb out of the vehicle and after a struggle, placed  
13 Webb in handcuffs. When Deputies spoke with Webb, he stated that he  
14 was trying to stop Murphy to figure out where he was going.
