The facts constituting the offense are:


COMPLAINT


COUNT III: On or about the 22nd day of June, 2013, the above-named defendant purposely or knowingly caused reasonable apprehension of serious bodily injury to another by pointing a gun in the direction of Bobby Bujan and firing three rounds.

COUNT IV: On or about the 22nd day of June, 2013, the above-named defendant purposely or knowingly caused reasonable apprehension of serious bodily injury to another by pointing a gun in the direction of Levi Miller and firing three rounds.

AFFIDAVIT OF PROBABLE CAUSE



Karla Painter, Deputy County Attorney of Missoula County, Montana, being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of JAMES ROBERT CASSIDY for allegedly committing the offenses set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.


On or about the 22nd day of June, 2012, Missoula County law enforcement to 6300 Lantern Ridge Lane #51 to investigate a disturbance in progress between a large group of people where one individual was firing a gun. Tawnya Snodgrass stated she was in trailer #54 when her 13-year-old daughter, Shaylynn Burklow, had approached her asking if they could leave because the defendant, James Cassidy, had made her feel uncomfortable by certain comments. Snodgrass informed her daughter they could

not leave because Snodgrass had been drinking. Snodgrass then went outside with three other individuals, Illya Foresek, Bobby Bujan, and Levi Miller, to confront the defendant. The defendant became confrontational and made unspecified threats to Foresteck who replied "I'm not afraid of you." The defendant then went inside his trailer (#51) and exited the front porch holding a handgun. The defendant pointed the handgun at Snodgrass, Foresteck, Bujan and Miller before firing three rounds. The victims fled the scene on foot. None of the individuals were hit by the bullets.


