11 and says that on or about December 31, 2013, in Missoula County, the
12 Defendant committed the offenses of COUNT I: ASSAULT WITH WEAPON,
13 a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-213,
14 punishable by 20 years MSP and/or \$50,000 fine and COUNT II: ASSAULT
15 WITH WEAPON, a Felony, in violation of Montana law, namely: Mont. Code
16 Ann. 45-5-213, punishable by 20 years MSP and/or \$50,000 fine.

18 The facts constituting the offense are:

20 COUNT I: On or about December 31, 2013, the above-named
21 Defendant purposely or knowingly caused bodily injury to "M. S." by
22 stabbing him with a knife or a similar sharp weapon.

25 COUNT II: On or about December 31, 2013, the above-named
26 Defendant purposely or knowingly caused bodily injury to "R.M." by
27 stabbing her with a knife or a similar sharp weapon.

14 M. SHAUN DONOVAN, Deputy Missoula County Attorney, being first
15 duly sworn upon oath, deposes and says:
16

17 I have read the official law enforcement reports regarding the
18 investigation of KURTIS LEE KILLSONTOP for allegedly committing the
19 offense(s) set forth in the complaint and based upon the information
20 contained in the reports, if true, believe probable cause exists to justify
21 charging the above-named defendant as specified in the accompanying
22 complaint.

25 On the evening of December 31, 2013 Officers of the Missoula Police
26 Department were called to a trailer home at 2250 1/2 West Sussex for a
27 report of a stabbing. At the scene they were told by witnesses that during
28

1 the course of a gathering of approximately six people one of the residents,
2 Kurtis Killsontop, had stabbed both "M.S." and "R.M." with a small knife or
3 other sharp weapon.
4

5 MS stated Killsontop had attacked him without provocation stabbing
6 him in the upper chest with what appeared to be a "makeshift shiv." The
7 wound was significant but did not require medical attention. MS's account
8 of being stabbed by the Defendant was corroborated by another witness
9 who said he saw Kurtis Killsontop stab both MS and RM.

12 At the scene RM told officers she had been stabbed by Killsontop and
13 had to be restrained by officers from attacking the Defendant. She was
14 treated at St. Patrick Hospital for a puncture wound in the back near her
15 shoulder blade. At the hospital she stated she did not want to press
16 charges and had blacked out immediately after feeling a searing pain in her
17 back.
