AFFIDAVIT OF PROBABLE

CAUSE

M. SHAUN DONOVAN, Deputy Missoula County Attorney, being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of KURTIS LEE KILLSONTOP for allegedly committing the offense(s) set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.

On the evening of December 31, 2013 Officers of the Missoula Police Department were called to a trailer home at 2250 1/2 West Sussex for a report of a stabbing. At the scene they were told by witnesses that during

the course of a gathering of approximately six people one of the residents, Kurtis Killsontop, had stabbed both "M.S." and "R.M." with a small knife or other sharp weapon.

MS stated Killsontop had attacked him without provocation stabbing him in the upper chest with what appeared to be a "makeshift shiv." The wound was significant but did not require medical attention. MS's account of being stabbed by the Defendant was corroborated by another witness who said he saw Kurtis Killsontop stab both MS and RM.

At the scene RM told officers she had been stabbed by Killsontop and had to be restrained by officers from attacking the Defendant. She was treated at St. Patrick Hospital for a puncture wound in the back near her shoulder blade. At the hospital she stated she did not want to press charges and had blacked out immediately after feeling a searing pain in her back.
