You might want to check out The Montana Judicial Code of Conduct, starting at Rule 4.1. These are mandatory rules that govern candidates for judicial office. The problem that jumped out at me was all of the elected people who are endorsing the current candidate, Matthew Lowy, and all of the elected people who endorsed recently past candidate, Kathleen Jenks. If memory serves me correctly, there was a billboard in the Rattlesnake with Jenks being endorsed by Mayor Engen. I think he also said stuff in the Missoulian about endorsing her. Those endorsements are specifically prohibited by the rules that govern judicial ethics. The Rules are retroactive. The past candidate, Jenks, can be disciplined by The Commission of Judicial Ethics for her violations. The current candidate, Matthew Lowy, is also subject to discipline.

The Montana Code of Judicial Conduct is mandatory and governs judges. It is scary to me that candidates who want to be judges are violating these rules. Given the current situation in Missoula government, it seems to me that at least judges should be free from corruption. Unethical behavior should not be tolerated in judges or judicial candidates, as spelled out in the Code of Judicial Conduct. An independent judiciary is essential.
