
COMPLAINT


The facts constituting the offense are:

AFFIDAVIT OF PROBABLE CAUSE

12 JORDAN KILBY, Deputy County Attorney, Montana, being first duly sworn upon
13 oath, deposes and says:


14 I have read the official law enforcement reports regarding the investigation of
15 MICHAEL JAMES BREWER for allegedly committing the offense(s) set forth in the
16 complaint and based upon the information contained in the reports, if true, believe
17 probable cause exists to justify charging the above-named defendant as specified in the
18 accompanying complaint.

20 On or about the 29th day of June, Missoula County Sheriff's Deputies responded
21 to 1297 Potomac Loop, in Missoula County, for the report of a male strangling a female.
22 They spoke with Jessica Brewer on the phone who stated her brother, Michael Brewer
23 had gotten upset with her. She stated he grabbed both sides of her collar and strangled
24 her with them by drawing them tightly together against her neck. She stated she could
25 not breathe the whole time. She said she thought he would kill her, strangle her until
26 she passed out or he would just stop. After Michael stopped strangling her, he stated,
27 "What are you going to do about that?"



2 stated his dad had gotten mad at Jessica and choked her. He made an angry face and
3 demonstrated choking with his hands.


