JORDAN KILBY, Deputy County Attorney, deposes and says that on or about the 19th day of October, 2014, in Missoula County, the Defendant committed the offenses of

The facts constituting the offense are:



13 oath, deposes and says:


14 I have read the official law enforcement reports regarding the investigation of
15 ASHLEY A. HUGHART for allegedly committing the offense(s) set forth in the complaint
16 and based upon the information contained in the reports, if true, believe probable cause
17 exists to justify charging the above-named defendant as specified in the accompanying
18 complaint.

20 On or about the 19th of October, 2014, Amanda Brown, called 911 when she saw
21 a group of children, run screaming into her home on the 1200 block of Toole Ave in
22 Missoula County. The kids yelled, "He's going to hurt us." She went to the open front
23 door and saw a man holding her daughter's pogo stick. She told the man to leave and
24 he dropped the pogo stick and left. She described him a male adult in his late 20's,
25 wearing a blue backpack, black pants, and a black tank top. She stated he left in the
26 direction of Magic Diamond Casino.

1 Officers located a male matching the description at the corner of Burton and
2 Toole, near the Magic Diamond Casino. They identified him as Ashley Hughart. Ashley
3 stated he had been involved in a disturbance with some juvenile girls. He said the girls
4 accused him of rape and then took his backpack. He said he threatened to call the
5 police and the girls returned his backpack. He denied grabbing a pogo stick.
6

7 KH stated the man chased her with the pogo stick and that she was scared he
8 was going to hit her so she ran from him. She said he was holding the stick like he was
9 going to swing it. JM stated she was initially holding the pogo stick. She stated the
10 man ran at them and she dropped the stick. She stated he picked up the stick and ran
11 after them. JW stated he saw the man yelling at a group of kids. JW stated the man
12 chased him through the yard with the pogo stick in his hand.
