Code Ann. 45-5-503, punishable by 100 years or life MSP and \$50,000 fine.

14 I have read the official law enforcement reports regarding the investigation of

17 exists to justify charging the above-named defendant as specified in the accompanying
18 complaint.

20 On May 18, 2015, Jane Doe, age 6, was brought to First Step for a forensic
21 interview after she disclosed to her mom that Lance Ring had put something "squishy"
22 in her mouth. She described him taking her to his bedroom and blindfolding her. He
23 then opened her jaw and put something "squishy" in her mouth. She didn't know what it
24 was but said it was bad.


