Code Ann. 45-5-213, punishable by 20 years MSP and/or \$50,000 fine; COUNT II: PARTNER OR FAMILY MEMBER ASSAULT - 1ST OFFENSE, a Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. 45-5-206[1st], punishable by not less than 24 hours or more than one year MCDF and/or a fine not less than \$100 or more than \$1000.

The facts constituting the offense are:

COUNT I: On or about the 24th day of July, 2015, the above-named Defendant purposely or knowingly caused reasonable apprehension of serious bodily injury in Jane Doe by use of a weapon or what reasonably appeared to be a weapon, to wit: a gun.

COUNT II: On or about the 24th day of July, 2015, the above-named Defendant purposely or knowingly caused bodily injury to Jane Doe, a partner, by punching her.

JORDAN KILBY, Deputy County Attorney, Montana, being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of JOEL ARTHUR GOLDER for allegedly committing the offense(s) set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.

On or about the 24th day of July, 2015 Dispatch received a report of a male pointing a gun at his mother and girlfriend at the 2100 block of South Reserve, which is within Missoula County. A later report stated the male's girlfriend, Jane Doe, had just arrived at Community Medical Center.

A Missoula City Police Officer interviewed Jane Doe. Jane Doe stated she and her significant other, Joel Golder, were arguing about infidelities within the relationship when he grabbed a hand gun and pointed it at her forehead. He then moved the handgun to his right and discharged the weapon inches from her left ear. Jane Doe

stated she was scared. Golder then took the gun and placed it up against his head. She was able to get the gun from Golder and locked the gun in her car. She stated she went back inside the building because she knew there was another gun in the building and Golder's mother was also there.

Jane Doe stated Golder's mother had the second handgun and somehow transferred it to Jane Doe. Golder then went after Jane Doe, pinning her up against the wall by her throat. Golder then punched Jane Doe in the face at least three times. Jane Doe was able to escape with the gun. She then drove to Community Medical Center. Her injuries were documented and are consistent with her report of what occurred.

A search warrant was executed on the building where the incident took place. A bullet was located lodged in the upper south wall of the business.
