
The facts constituting the offense are:

AFFIDAVIT OF PROBABLE CAUSE

JENNIFER CLARK, Deputy County Attorney, Montana, being first duly sworn upon
oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of
NICHOLAS JAMES DOLSON for allegedly committing the offense(s) set forth in the
complaint and based upon the information contained in the reports, if true, believe
probable cause exists to justify charging the above-named defendant as specified in the
accompanying complaint.

On June 12, 2015, Missoula City Police Officer Erickson met Jane Doe regarding
a sexual assault that occurred at the Sleepy Inn. Doe stated that she met the male,
later identified as Nicholas Dolson, after he responded to her Craigslist ad in the casual
encounters. They agreed to meet for sexual intercourse. When he arrived, he told her
to "get naked." She did and they engaged in consensual vaginal intercourse. He then
forced his penis into her rectum. She told him to stop because she did not want to have
anal sex. He refused and placed his hand onto the back of her neck and continued to
forcefully penetrate her anus.

1 The following day, Dolson texted her and stated, "I had it planned out fuck u for a
2 few min and slam it in ur ass and walk away."

3 Detective Waln and Detective Franke interviewed Dolson. He admitted meeting
4 Doe online and meeting her for sex. He stated that he asked if he could "do anything
5 else" and she said she didn't care. He then pulled his penis out of her vagina and put it
6 in her anus. He stated she seemed shocked, surprised and she was not expecting him
7 to put his penis in her anus. He said it must have hurt her because she tensed up and
8 told him to stop.

11 Dolson admitted sending the text to Doe and that it was his plan. He stated that
12 when he meets up with women for sex, he usually does the same thing. He has vaginal
13 sex and asks if he can do anything else. He then puts his penis in their anus. He said
14 "9 out of 10" aren't into it.


