AMENDED COMPLAINT


10 BRIAN LOWNEY, Deputy County Attorney, deposes and says that on or about the
11 12th day of October, 2015, in Missoula County, the Defendant committed the offenses of
12 COUNT I: VIOLATION OF ORDER OF PROTECTION - 1ST OFFENSE, a Misdemeanor,
13 in violation of Montana law, namely: Mont. Code Ann. 45-5-626(3)[1st], punishable by 6
14 months MCDF and/or \$500 fine; COUNT II: ATTEMPTED SEXUAL INTERCOURSE
15 WITHOUT CONSENT, a Felony, in violation of Montana law, namely: Mont. Code Ann.
16 45-5-503, punishable by not less than 2-4 years or more than 100 years or life MSP and
17 \$50,000 fine.

19 The facts constituting the offense are:


21 COUNT I: On or about the on, about or around the week of October 5th, 2015,
22 through the date of October 12, 2015, the above-named Defendant committed the
23 offense of violation of an order of protection when, with knowledge of the order,
24 purposely or knowingly violated a provision of an order provided for in 40-4-121 or an
25 order of protection under Title 40, chapter 15, to wit: he had contact with Jane Doe.

1 COUNT II: On or about the 12th day of October, 2015, the above-named
2 Defendant knowingly attempted to have sexual intercourse with Jane Doe without
3 consent.

1 let her go. The Defendant began to "hump" Doe. The Defendant then pulled down
2 Doe's pants to her hips. The Defendant took his penis out of his own pants, moved
3 Doe's underwear to the side, and placed his penis in Doe's underwear, near her
4 genitals. The Defendant continued to "hump" Doe, and eventually ejaculated.
5

6 An order of protection was in place at the time the Defendant had contact with
7 Doe, which prohibits the Defendant from having contact with Doe. The order was
8 served upon the Defendant in open court.
9

10 The Defendant admitted to having contact with Doe, but denied that he sexually
11 assaulted her.
