AFFIDAVIT OF PROBABLE CAUSE

JENNIFER CLARK, Deputy County Attorney, Montana, being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of MIKOL AARON ASPINWALL for allegedly committing the offense(s) set forth in the complaint and based upon the information contained in the reports, if true, believe probable cause exists to justify charging the above-named defendant as specified in the accompanying complaint.

On August 12, 2015, Detective Chris Shermer met with the father of Jane Doe, age 13. Doe had been sending inappropriate pictures from her smartphone. She began communicating with Instagram user "Daddy4kitten" who was later identified as Mikol Aspinwall. Jane Doe informed Aspinwall that she was 14 and then later told him that she was 13. He indicated that he was old enough to be her father and that they were 29 years apart in age. He had stated under his user name "Strictly Daddy" that he liked "agegap more=better" indicating that he liked people younger than him.

He sent sexual messages to Doe. He first told her he was lying on his bed naked and sent a picture of a naked left leg and an erect, adult penis. He stated he wished she was there. They began discussing sex positions and made a fake Instagram account together called @daddyandme5.

When the conversations continued, She advised him that she was 13. He asked her if she could handle what he sent in the DM (direct message) referring to his naked penis. He commented that he didn't know if he could wait until she was 18. He also stated that he didn't know if he would let her stay a virgin. He stated that he wanted to feel "my seed fill you," "holding your hips close and not letting you pull away," and "laying on top of you, pinning you under me. Holding your wrists above your head." He stated his nickname was Mike by saying, "Mine is mike, but I want you to call me daddy. Or Sir or Master depending on the situation." He asked her to "Send me something cute or sexy for me to wake up to." He instructed her to take off her panties and that he wanted her "bare pussy pressed against my side." She stated that she wanted to go live with him. He told her, "Good, I want to see your 13 yo tittles. Do you want me to see them." Doe sent him a picture of her exposed breast. The conversation continued and she requested a picture of his penis. He stated "if you send me a good set, I may even show you with precum drops at the tip." He did send her a picture of his penis and stated "Come sit on my lap little girl." After a few more texts, she sent him a picture of her vagina. He replied, "Pretty pussy. It is mine. Open your legs wider, like you want to do for me."
