Markets ended the session higher as positive earnings outshined disappointing economic data. At the closing bell, the Dow Jones advanced 88 points to 13,090, the S&P 500 added 19 points to 1391 and the Nasdag gained 68 points to 3030. Composite volume on the NYSE was 3.9 billion shares with advancing issues besting decliners by 3-1. The Nasdaq was 3-1 positive on issues as well. A weaker-than-expected March durable goods orders had little effect in discouraging investors following several strong corporate profit tallies and an upward revision in the Federal Reserve's economic growth forecast. This afternoon, the FOMC supplied a more optimistic outlook, lowering their unemployment rate estimate to a 7.8% to 8% range and lifting their U.S. GDP projection to a range of 2.4% to 2.9%. In addition, Chairman Bernanke reiterated the Fed's commitment to intervene should the economy weaken and to keep rates low through late 2014. All 10 sectors on the S&P finished higher, led by tech stocks. Shares of Apple rallied \$49.72 to \$610.00 after strong iPhone sales in China helped the company exceed analysts' expectation in the quarter. Also among earnings, Boeing advanced \$3.87 to \$77.08 and Harley Davidson added \$3.13 to \$53.49 after both companies reported strongerthan-expected results. On the downside, Caterpillar gave up \$4.96 to \$103.44 as revenues came in lighter than estimates. In bondland, Treasuries were modestly lower along the curve. The 10-year note was down 4 ticks to yield 1.99%.
