



## **Pick Your Trip Workday Getaway** **RULES AND REGULATIONS**

**1. NO PURCHASE NECESSARY TO ENTER.** The contest is open to any person 18 years of age and older, who is a New Jersey/Atlantic City total survey area based on Arbitron resident with a valid ID. Anyone who enters or participates in this contest is subject to and agrees to abide by the official rules as stated. All federal, state and local laws and regulations apply. Taxes are the sole responsibility of the winners. Void where prohibited.

**2. HOW TO QUALIFY:** Keep your Radio on Today's Lite Rock 96.9 WFPG and be caller #9 at 1-800-969-WFPG when we play the Pick Your Trip Workday Getaway sounder around 9:20am, 11:20am, 1:20pm and 4:20pm and then we'll pick a Lite Rock Listener Club member at 6:20pm at random for a chance qualify to win ONE of TWO trips. – (a) A family trip for four to Universal Studios in Florida including airfare, two day park passes for four and three nights plus four days at the Cabana Bay Beach Resort inside Universal (travel 9/11/17-9/14/17). OR (b) An all-inclusive getaway for two to the Caribbean for three nights and four days with airfare, hotel, unlimited dining and drinking. WFPG-FM Lite Rock 96.9 will conduct the contest beginning on or around 4/24/17 – 5/16/17. All qualifiers must appear at the Workday Getaway grand prize party on Tuesday, May 16th, 2017 at Angelo's Fairmont Tavern in Atlantic City. Qualifiers must check in by 6PM. TECHNICAL ISSUES:** In the event that there is an EAS Alert or technical problem with the telephones or equipment etc. beyond WFPG-FM Lite Rock 96.9's control during the contest, the contest will cease at that moment and all parties on the line will be disconnected. The contest will resume after the telephone problem has been corrected. The contest will resume after the telephone, EAS or technical problem has been corrected. Due to the nature of our programs that are heard on-line over the internet, programs heard on this radio station's internet audio stream are slightly delayed from the time the programs are heard on the broadcast station, and will be running behind the broadcast signal. Thus, all content heard, including news alerts, contests, traffic reports, and more are delayed. This delay can last for as much as 30 seconds or more. This also means that when WFPG contests are played that requires a specific caller to telephone the radio station, listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contests on-air. In any event those who participate in the station's contests by listening over the Internet, should take this time delay circumstance into account in calculating the actual dealing within which they must call the station.

**4. RESTRICTIONS:** Employees of WFPG-FM Lite Rock 96.9, employees of other radio stations in Atlantic/Cape May County, and their immediate families may not participate and are not eligible to win. The term "immediate families" includes spouses, grandparents, parents, siblings, children, and grandchildren. Persons who have won another contest worth over \$400 in the past 30 calendar days before the contest are ineligible to win. WFPG-FM Lite Rock 96.9 winners can only win once during the duration of this contest. Only one winner per household.
