- 1. WHO MAY PARTICIPATE. Subject to the additional restrictions below, all KLAQ Contests are open to legal residents of the States of Texas and New Mexico who are 18 years of age or older at the time of entry, are legal U.S. residents, and who possess valid government-issued photo identification.
