

**2019 COUNTRY MEGATICKET  
APP/ONLINE CONTEST RULES  
Townsquare Media WOKQ-FM**

1. How to Enter the Contest:

- a. The **2019 COUNTRY MEGATICKET** (“Contest”) will run from Monday January 21<sup>st</sup> 12:00AM through Friday February 1<sup>st</sup> 11:59PM 2019 by WOKQ-FM (“Station”).
- b. To participate in the Contest, listeners must have the WOKQ app to receive the code word notification. Listeners will enter that code word in to the respective day at WOKQ.com. Station is not responsible for any lost, disconnected, dropped, misdirected or incomplete telephone calls, or any internet connection or website/browser error.
- c. Only one person will win the Prize at the end of the contest. Winner will be chosen at random with station discretion.

2. Eligibility Restrictions:

- a. The contest is open to all Station listeners who are legal United States citizens 5 years of age or older and who reside in the WOKQ listening area. Contest participants under the age of 18 must be accompanied by a parent or legal guardian at the event and must be represented accordingly on the registration form. Employees of Station, its licensee, Townsquare Media, their subsidiaries, affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations and the members of their immediate families are ineligible to participate or win. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household.
- b. Listeners are eligible to win a Station contest only once every thirty days. Only one winner per household is permitted in any contest.
- c. Participants in the Contest must possess a valid government issued photo identification and must present it to receive the prize if selected as the winner.

3. Prizes:

- a. ONE winner will receive a **PAIR OF BRONZE 2019 COUNTRY MEGATICKETS TO THE XFINITY CENTER IN MANSFIELD MASSACHUSETTS. THE MEGATICKET INCLUDES A PAIR OF TICKETS TO SEVEN COUNTRY SHOWS. The station is not responsible for any changes or cancellations to the list of shows included in the Megaticket.**

- b. All prizes or prize certificates may be picked up at the Stations' office located at 292 Middle Road in Dover, NH. Any prize or prize certificate not claimed within ninety (90) days of winning will be automatically forfeited by the winner, unless a prize has an expiration date, in which case a prize may be forfeited earlier than ninety days from winning. In the event that a prize or prize certificate is mailed to the winner, winner assumes the risk of its arrival. Station is not responsible for the safe arrival of a prize or prize certificate, i.e. not responsible for late, lost or stolen mail.
- c. Contest prizes are not transferable. Prizes may not be substituted or redeemed for cash.
- d. Prizes are limited solely to those items explicitly set forth herein and shall not include any and all other expenses, incidentals or taxes that may arise out of the winner's receipt of this prize.
- e. Prizes will be awarded as is, with no written or express warranty.

4. Selection of Winners:

- a. Decisions of Station management with respect to the Contest are final.
- b. One winner will be chosen at random after the duration of the Contest.
- c. The odds of winning are based on the number entries received.

5. Conditions:

- a. Photo identification and social security number of the Prize winner will be required in order to collect the prize. Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners will be required to sign an IRS Form W-9 or the equivalent. If applicable and required by law, the Winner will receive a 1099 Misc Income IRS Tax form for the value of the prize as stated in these Contest rules.
- b. Winner is required to sign a release in order receive the prize. Failure or refusal to execute the release will result in winner forfeiting the prize. Pursuant to the liability release, winners will agree to hold Station, its licensee, Townsquare Media, their subsidiaries, affiliated companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- c. By participating in the Contest, the winner or winners (and their guest or traveling companion, if applicable) agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest without additional financial or other compensation.

- d. Station in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station website(s) or who is otherwise in violation of the rules. Station further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. Station reserves the right in its sole discretion to modify the Contest rules and dates at any time for any reason. Material modifications shall be announced on-air, when practical. By participating in this Contest, you agree to be bound by these Contest rules, any modifications thereof, and by all other rules imposed by Station management. If due to circumstances beyond the control of Station, any event associated with this Contest or the prize is delayed, rescheduled, postponed or cancelled, Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- f. No purchase is necessary. The Contest is void where prohibited.
- g. Failure to comply with the Contest rules may result in a contestant's disqualification, at the sole discretion of Station.
- h. Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest or in the announcement of a prize.
