2011 FOX66 The X FACTOR AUDITION PASS CONTEST RULES

Who Can Enter

- 1. To be eligible to participate in this audition, entrants must be U.S. and Michigan residents who are 12 years of age or older as of March 1, 2011, and reside in the WSMH viewing area.
- 2. How to Enter

- 1. No purchase is necessary to enter.

Each entrant may consist of an individual or a group. Only the first sixty-six (66) registered entrants will receive an audition number. Registration starts on Monday, March 21, 2011 by 10am.
- 3. On April 9, 2011, the Station will hold an audition at Courtland Center 4190 E. Court Street Burton, MI 48509 from 12pm to 3pm. All Entrants (including each individual within a group entry) must check-in by 11:30 a.m., show proof of age, and sign a consent/release form before being able to audition. The check-in process will start at 10am. Entrants under 18 years of age must have parent or guardian sign a consent/release form and be present during the audition process. Anyone not having a valid state ID or driver's license will not be allowed to audition.
- 4. Following the check-in process, auditions will be held starting at 12pm on April 9, 2011. Only the sixty six (66) registered and checked-in entrants will audition for the

In the event of a tie, a tie breaker round will take place and each of the tied entrants will be re-judged based on the above criterion.

- 6. All entries (including video and audio tape) become property of the Station and will not be returned. Station is not responsible for late, lost or misdirected entries or for printing errors.
