JENNIFER CLARK, Deputy Missoula County Attorney, being duly sworn,  
deposes and says that on or about the 6th day of August, 2012, at Missoula  
County, the above-named Defendant committed the offense(s) of COUNT I:  
SEXUAL ABUSE OF CHILDREN, a Felony, in violation of Montana law, namely:  
Mont. Code Ann. §45-5-625(c), punishable by Life or 100 years MSP and a  
\$10,000 fine; COUNT II: INDECENT EXPOSURE - 1ST OFFENSE, a  
Misdemeanor, in violation of Montana law, namely: Mont. Code Ann. §45-5-  
504(1)[1st], punishable by 6 months MCDP and/or \$500 fine.

The facts constituting the offense(s) are:

COUNT I; On or about the 6th day of August, 2012, the above-named  
Defendant committed the offense of sexual abuse of children by knowingly, by  
any means of communication, including electronic communication, entices or  
counsels a child to engage in sexual conduct.

COUNT II: On or about the 6th day of August, 2012, the above-named  
Defendant committed the offense of indecent exposure by knowingly or  
purposely exposing his genitals under circumstances in which the Defendant

knew the conduct was likely to cause affront or alarm in order to arouse or gratify the Defendant's own sexual response or desire or the sexual response or desire of any person.

JENNIFER CLARK, Deputy County Attorney of Missoula County, Montana,  
being first duly sworn upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of  
KEVIN ROBERT KICHNET for allegedly committing the offense(s) set forth in the  
complaint and based upon the information contained in the reports, if true, believe  
probable cause exists to justify charging the above-named defendant as specified  
in the accompanying complaint.

On August 6, 2012, Deputy Pavalone received a report that the  
complainant's 14 year old daughter was receiving obscene text messages. C.H.  
received a text message from an unidentified caller on August 5, 2012, from 406-  
880-2156. The male identified himself as Kevin Johnson. He is later identified as  
Kevin Kichnet. C.H. asked how he got her number and asked about his identity.

He sends a picture of himself and requests a photo in return. She tells him to leave her alone and that her dad is a cop. He replies that he has the wrong number.

C.H. tells her parents. They begin communicating with Kitchnet through texts. They tell him that it is a girl name "Christy". Kitchnet asks how old she is and they reply 14. Kitchnet then proceeds to ask for pictures of her "titts" and sends a picture of his penis.
