


10 JASON MARKS, Deputy Missoula County Attorney, deposes and says



17 I have read the official law enforcement reports regarding the
18 investigation of ERIC SVEN WENGREN for allegedly committing the
19 offense(s) set forth in the complaint and based upon the information
20 contained in the reports, if true, believe probable cause exists to justify
21 charging the above-named defendant as specified in the accompanying
22 complaint.

25 On or about the 20th day of December, 2012, Officer Devins of the
26 Gillette Wyoming Police Department contacted law enforcement in
27 Missoula regarding a man named Eric Wengren who resides in Lolo. She


1 relayed that Wengren had communicated with his cousin and various other
2 people, who reside in Gillette, that he was going to commit a school
3 shooting at a school in Gillette.

5 Wengren was interviewed by deputies at his mother's house in Lolo.
6 He admitted making the threats but said that he had been joking and
7 thought the people he had been communicating with knew that. His mother
8 confirmed that there are no guns in the residence and that neither of them
9 own a gun.
