11 JENNIFER CLARK, Deputy County Attorney, deposes and says that On or about
12 and between August 2, 2015, and August 12, 2015, in Missoula County, the Defendant
13 committed the offense of SEXUAL ABUSE OF CHILDREN - VICTIM UNDER AGE OF 16,
14 a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-625, punishable by
15 Life or not less than 4 years or more than 100 years and a \$10,000 fine.

17 The facts constituting the offense are:

18 On or about and between August 2, 2015, and August 12, 2015, the above-
19 named Defendant committed the offense of sexual abuse of children by knowingly
20 persuades, entices, or counsels a child, to engage in sexual conduct, whether actual or
21 simulated. The victim was under 16 years of age.

AFFIDAVIT OF PROBABLE CAUSE

12 JENNIFER CLARK, Deputy County Attorney, Montana, being first duly sworn upon
13 oath, deposes and says:

14 I have read the official law enforcement reports regarding the investigation of
15 MIKOL AARON ASPINWALL for allegedly committing the offense(s) set forth in the
16 complaint and based upon the information contained in the reports, if true, believe
17 probable cause exists to justify charging the above-named defendant as specified in the
18 accompanying complaint.
19

20 On August 12, 2015, Detective Chris Shermer met with the father of Jane Doe,
21 age 13. Doe had been sending inappropriate pictures from her smartphone. She
22 began communicating with Instagram user "Daddy4kitten" who was later identified as
23 Mikol Aspinwall. Jane Doe informed Aspinwall that she was 14 and then later told him
24 that she was 13. He indicated that he was old enough to be her father and that they
25 were 29 years apart in age. He had stated under his user name "Strictly Daddy" that he
26 liked "agegap more=better" indicating that he liked people younger than him.


1 He sent sexual messages to Doe. He first told her he was lying on his bed naked
2 and sent a picture of a naked left leg and an erect, adult penis. He stated he wished
3 she was there. They began discussing sex positions and made a fake Instagram
4 account together called @daddyandme5.

6 When the conversations continued, She advised him that she was 13. He asked
7 her if she could handle what he sent in the DM (direct message) referring to his naked
8 penis. He commented that he didn't know if he could wait until she was 18. He also
9 stated that he didn't know if he would let her stay a virgin. He stated that he wanted to
10 feel "my seed fill you," "holding your hips close and not letting you pull away," and
11 "laying on top of you, pinning you under me. Holding your wrists above your head." He
12 stated his nickname was Mike by saying, "Mine is mike, but I want you to call me daddy.
13 Or Sir or Master depending on the situation." He asked her to "Send me something
14 cute or sexy for me to wake up to." He instructed her to take off her panties and that he
15 wanted her "bare pussy pressed against my side." She stated that she wanted to go
16 live with him. He told her, "Good, I want to see your 13 yo titties. Do you want me to
17 see them." Doe sent him a picture of her exposed breast. The conversation continued
18 and she requested a picture of his penis. He stated "if you send me a good set, I may
19 even show you with precum drops at the tip." He did send her a picture of his penis and
20 stated "Come sit on my lap little girl." After a few more texts, she sent him a picture of
21 her vagina. He replied, "Pretty pussy. It is mine. Open your legs wider, like you want
22 to do for me."


