
**COMPLAINT**

JENNIFER S. CLARK, Deputy County Attorney, deposes and says that on or about December 2, 2106, in Missoula County, the Defendant committed the offense of COUNT I: SEXUAL ABUSE OF CHILDREN, a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-625, punishable by Life or 100 years MSP and a \$10,000 fine.

The facts constituting the offense are:


COUNT I: On or about December 2, 2016 the above-named Defendant committed the offense of sexual abuse of children by knowingly filming, Jane Doe, a child, engaging in sexual conduct by using her cellphone to record them having sexual intercourse.

AFFIDAVIT OF PROBABLE CAUSE

24 JENNIFER S. CLARK, Deputy County Attorney, Montana, being first duly sworn  
25 upon oath, deposes and says:

26 I have read the official law enforcement reports regarding the investigation of  
27 JUSTIN ROBERT WIEDER for allegedly committing the offense(s) set forth in the  
28 complaint and based upon the information contained in the reports, if true, believe  
probable cause exists to justify charging the above-named defendant as specified in the  
accompanying complaint.

On December 7, 2016, Missoula County Sheriff Deputy Orr took a report from  
Hellgate High School social worker Traci Ledierd that an anonymous witness disclosed

1 concerning information about Jane Doe, age 16. She was told that Jane Doe was being  
2 forced to have sex with males by her boyfriend and record the acts.

3  
4 On December 13, 2017, Detective White contacted Doe's mother and learned  
5 that she is having contact with Justin Weider. Weider was charged with sexual  
6 intercourse without consent and sexual abuse of children and Doe is one of the victims  
7 in that case. Judge Townsend has ordered Weider to not have contact with Doe  
8 through those cases. Doe's mother reported that Wieder's grandfather has dropped  
9 Doe off and she believes Doe rides the bus to the mall to meet Wieder.  
10

11 Detective White was able to identify the witness and confirmed that Doe told her  
12 Wieder has her have sex with other guys and has her record it.


13 On December 20, 2017, Doe's mother contacted Detective White and informed  
14 him that Doe was planning to go to Wieder's house that day. Deputy Justin White  
15 responded to Wieder's home and found Doe present. Wieder was arrested for violating  
16 his conditions of release.

18 On December 21, 2017, Detective White and Detective Deibert interviewed  
19 Wieder. Wieder initially denied having contact with Doe. When confronted with the text  
20 messages between them and the video of them having sex, Wieder admitted having  
21 contact. He stated that Doe wanted to do the recording and the he was holding the  
22 phone because he had a better angle. Detective White confirmed that he was the one  
23 videoing the sexual conduct and he admitted that he was. He stated sexual intercourse  
24 occurred at his residence.

1 Defendant continues to have contact with Doe despite being revoked on his  
2 conditions and being ordered to not have contact. His release was revoked in  
3 December 2016, for having contact with Jane Doe. It was recently learned that she is  
4 six-weeks pregnant and Defendant is the father. She admitted to having sexual  
5 intercourse with him in June 2017.


