On Friday September 27, 2013 at approximately 2019 hours, Deputies were dispatched to 307 Deshotel Lane, The Tabernacle of Praise Worship Center, in reference to a shooting. Upon arrival Deputies noticed multiple people running out of the building into the parking lot along with multiple LCPD officers on scene. Deputies spoke with several people in the parking lot who all stated the subject later identified as Woodrow Karey came into the church with a gun raised, pointed at the victim Ronald Harris Sr then fired two shots. Witnesses stated Woodrow fled the church exiting through the north side exit door. Woodrow then fled on foot in an unknown direction. Dispatch stated Woodrow was on the phone telling Deputies where he was located. A few seconds later Dispatch advised Woodrow was in custody. Deputies Roy Jones, Cody Soileau, Nathan McKee located and cuffed Woodrow in an empty lot North of Opelousas St, west of Deshotel Ln. Deputy McKee advised Woodrow his Miranda Rights. Deputies along with LCPD officers made entry into the church and noticed multiple people sitting in a pew at the north exit door. Deputies noticed Ronald lying on the floor next to the front pew at the north exit door. After clearing the church of any other possible threats, Acadian Ambulance began their assessment of Ronald and advised Deputies they were unable to find any vitals on Ronald. Deputies then notified Violent Crimes Detectives along with the FIU Division and the Coroners Office.

After Deputy McKee advised Woodrow of his Miranda Rights, McKee asked what happened. Woodrow stated several times "He raped my wife". McKee asked Woodrow where the guns were located Woodrow then nodded over his shoulder towards the woods. Deputy Soileau located the weapons. Deputy McKee then asked Woodrow again what happened tonight and Woodrow once again stated "He raped my wife". Deputy McKee then asked Woodrow did you shoot somebody tonight? Woodrow then replied "yes". Woodrow was placed into the back of Unit 213. Deputy McKee then repositioned his vehicle, with his headlights pointing to the location of the weapons in the woods, while Deputy Bennett stayed at the unit with Woodrow.

A Crime Scene Log was started at 2038, at 2108 hours Violent Crimes Detective Brent Young arrived and took control of the crime scene. All witness information was gathered and handed over to Detective Young who advised he would add in a supplement report at a later time. The subject was transported to the Sheriffs Office for questioning by Detectives, and was then transported to the Calcasieu Correctional Center for booking. The two firearms were recovered from the scene by FIU.
