A review of the Memorandum of Agreement between Law enforcement and Black Horse Regional Board of Education which requires the notification of a potential abused child to law enforcement. Statement from a teacher that she met with the defendant, in her capacity as Principal, and told her that a student had confided that other students were engaging in sexual relationships with teachers. Defendant was advised that the student had been to one of the teacher's houses with one of the victims. It was also reported to the defendant that text messages had been seen between the victim and teacher and that the student had received text messages from the teacher about how much he liked the victim. Statement of Parent of victim that he was informed by the defendant that his child went on a car ride with the teacher, but was never informed of the allegations of sexual acts between his child and the teacher. Statement of student that she was interviewed by defendant and told defendant that the teachers and students were "hooking up." Statement of witness indicating that he was advised by defendant to delete any student contact from his phone. Defendant's admission that she was in denial when she heard the allegations and was trying to protect the teachers. Defendant's admission that she did not notify law enforcement or the DYFS.

Specifically, defendant admitted that he had kissed victim and touched her intimate parts on multiple occasions during the school year. The Black Horse Pike Regional Board of Education Policy #3281, which was acknowledged and signed by defendant, prohibited inappropriate comments, inappropriate language and inappropriate conduct of a sexual nature toward or with pupils.
