

Free 3-year Lease from Nissan of Atlantic City  
Rules and Regulation

**PROMOTION DESCRIPTION:** Nissan of Atlantic City-Lease Promotion (the "Promotion") begins on or about 12/6/2019 and ends on 2/1/2020 (the "Promotion Period"). The Promotion consists of a random draw sweepstakes (the "Sweepstakes") as described below. Entry in the Promotion does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Nissan of Atlantic City 6021 E Black Horse Pike, Egg Harbor Township, NJ 08234 ("Sponsor"), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal US, residents who are twenty one (21) years of age or older and possess a valid U.S. driver's license are eligible to enter. Must be a NJ resident with proof of residency to qualify. The Title Sponsor, Nissan of Atlantic City, and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors, agents employees, successors and assigns (collectively, the "Promotion Entities") and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Promotion or win a prize. order to be eligible to participate. Contestants not selected as a finalist will not receive notification. Sponsor shall have no liability for any finalist notification that is lost, intercepted or not received by a potential finalist for any reason. If Potential Sweepstakes prize winner is found to be ineligible or if he or she has not complied with these Official Rules or declines the Sweepstakes prize for any reason prior to award, such potential Sweepstakes prize winner will be disqualified and an alternate Sweepstakes prize winner may be selected. Winner will be required to show proof of currently valid driver's license and insurance prior to taking delivery of the vehicle. **WINNER MUST QUALIFY FOR APPROVAL FROM NMAC TIER 1-3.** *Minimum credit score (Tire 3) is 700 on Experian, Must be in good standing with creditors.* **WINNER MUST PRESENT A VAILD PROOF OF FULL COVERAGE INSURANCE.** *Vehicle lease agreement requires that Nissan of Atlantic City buy insurance which provides (a) comprehensive (maximum deductible \$1,000), (b) collision (maximum deductible \$1,000), (c) property damage liability (minimum \$50,000 per occurrence), and (d) bodily injury liability (minimum \$100,000 per person and \$300,000 per occurrence).* The winner shall bear all risk of loss or damage to the prize vehicle after it has been awarded.
