The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Manslaughter in the Second Degree

Minnesota Statute: 609.205(1)

Maximum Sentence: 10 years imprisonment and/or \$20,000 fine

Offense Level: Felony

Offense Date (on or about): 01/21/2014

Control #(ICR#): 14002148

Charge Description: On or about January 21-22, 2014, in the County of Dodge, the Defendant, Darrian James Rice, did cause the death of another by his culpable negligence whereby he created an unreasonable risk, and consciously took chances of causing death or great bodily harm to another.

COUNT II

Charge: Contributing to the Delinquency of a Minor

Minnesota Statute: 260B.425.1(a)

Maximum Sentence: 1 year imprisonment and/or \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/21/2014

Control #(ICR#): 14002148

Charge Description: On or about January 21-22, 2014, in the County of Dodge, the Defendant, Darrian James Rice, did by act, word, or omission encourages, causes, or contributes to delinquency of a child or to a child's status as a juvenile petty offender.

STATEMENT OF PROBABLE CAUSE

Complainant is a sworn deputy of the Dodge County Sheriff's Office, who bases this complaint upon facts obtained from his own investigation and/or that of other law enforcement officers whom he believes to be reliable.

On January 19, 2014, Olmsted County deputies took a theft report from David Brian Graddy (DOB: 12-8-1964) and Susan Lynn Graddy (DOB: 12-9-1964). The Graddy's reported that \$600 in cash had been taken from their locked bedroom closet and that the closet had sustained damage. The Graddy's believed their son, Noah Samuel Graddy (DOB: 5-28-1998), had broken into the closet and stole the money.

On January 23, 2014, the Graddy's filed a missing persons report with Olmsted County for Noah. They stated that they had not seen or heard from him since the money was stolen on January 19, 2014. The Graddy's reported that the last time they saw Noah he was wearing a gray braided rug style hooded sweatshirt, blue jeans, black rimmed glasses, skateboard style shoes, and a purple/gray patterned snowboard jacket. The Graddy's also reported that Noah was known to hang out with a crowd of kids from Kasson.

On January 24, 2014, while doing follow up on the whereabouts of Noah Graddy, Deputy Deputy Deets, spoke with L.A.H. (DOB: 11-22-1996). L.A.H. reported that she last saw Noah on January 22, 2014, at the home of M.R. (DOB: 8-7-1997).

Further investigation revealed that on January 21, 2014, Noah Graddy was with L.A.H., M.R., and R.S.P. (DOB: 6-25-1996) at M.R.'s residence. L.A.H. then drove Noah and R.S.P. into Rochester where they purchased Methamphetamine. After purchasing the Meth the three of them then went to the home of Darrian James Rice (DOB: 10-31-1994). Noah, Darrian, L.A.H., and R.S.P. then spent the night in Rice's room getting high on Triple C and Methamphetamine.

In the early morning hours of January 22, 2014, Rice and R.S.P. became annoyed with Noah because he began to act strange and was being loud. They were afraid he would wake up Rice's grandmother who was sleeping in a nearby room. R.S.P. admits that he shoved Noah at one point and Rice admitted that he told Noah to get out of the residence. Noah became upset, left the bedroom and eventually left the residence. Noah reportedly left a note stating, "thanks for using me until all my money was gone." When Noah Graddy left the Rice Residence on foot that morning the temperature was between -9 and -20 degrees Fahrenheit. This was the last time Noah Graddy was seen alive.

It was known to law enforcement that on previous occasions Noah walked the railroad tracks to get between his home in Byron and Kasson. On March 20, 2014, members of the Kasson Police Department, Olmsted County Task Force, and Dodge County Sheriff's Office participated in a planned search for Noah. During this search of the area around the tracks east of Kasson law enforcement found the body of Noah Graddy buried in the snow in a fetal position.

According to the Corner's Final Autopsy Report, Noah Graddy, age 15, died of acute intoxication due to the combined effects of bupropion, methamphetamine, dextromethorphan, chlorpheniramine, and hypothermia due to environmental exposure.
