The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Aggravated Robbery-1st Degree**

Minnesota Statute: 609.245.1, with reference to: 609.245.1, 609.11.5(a)

Maximum Sentence: Not less than 3 years nor more than 20 years in prison or \$35,000 fine or both (MSG SL 8)

Offense Level: Felony

Offense Date (on or about): 11/14/2019

Control #(ICR#): 19056046

Charge Description: On or about November 14, 2019, within the County of Olmsted, Jaeden Mikkel Adcox , having knowledge of not being entitled thereto, did wrongfully, unlawfully and feloniously take personal property from the person or in the presence of another, to-wit: took money and Tramadol from Victim 1, and used or threatened the imminent use of force against any person to overcome the person's resistance or powers of resistance to, or to compel acquiescence in, the taking or carrying away of the property and Jaeden Mikkel Adcox was armed with a dangerous weapon, to-wit: .22 caliber pistol, or any article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon, or inflicted bodily harm upon another.

**COUNT II**

**Charge: Possess Ammo/Any Firearm-Conviction or Adjudicated Delinquent for Crime of Violence**

Minnesota Statute: 624.713.1(2), with reference to: 624.713.2(b), 609.11.5(b)

Maximum Sentence: Not less than 5 years nor more than 15 years in prison, a \$30,000 fine or both (MSG SL 6)

Offense Level: Felony

Offense Date (on or about): 11/14/2019

Control #(ICR#): 19056046

Charge Description: On or about November 14, 2019, within the County of Olmsted, Jaeden Mikkel Adcox did wrongfully, unlawfully, and feloniously possess ammunition or a pistol or semiautomatic military-style assault weapon or, except for clause (1), any other firearm and Jaeden Mikkel Adcox has been convicted of, or adjudicated delinquent or convicted as an extended jurisdiction juvenile for committing, in this state or elsewhere, a crime of violence.

### COUNT III

**Charge: Assault in the Second Degree**

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.11.5(a)

Maximum Sentence: Not less than 3 years nor more than 7 years in prison, \$14,000 fine or both (MSG SL 6)

Offense Level: Felony

Offense Date (on or about): 11/14/2019

Control #(ICR#): 19056046

Charge Description: On or about November 14, 2019, within the County of Olmsted, Jaeden Mikkel Adcox did wrongfully, unlawfully and feloniously assault another, to-wit: Victim 1, with a dangerous weapon, to-wit: .22 caliber pistol.

### COUNT IV

**Charge: Assault in the Second Degree**

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.11.5(a)

Maximum Sentence: Not less than 3 years nor more than 7 years in prison, \$14,000 fine or both (MSG SL 6)

Offense Level: Felony

Offense Date (on or about): 11/14/2019

Control #(ICR#): 19056046

Charge Description: On or about November 14, 2019, within the County of Olmsted, Jaeden Mikkel Adcox did wrongfully, unlawfully and feloniously assault another, to-wit: Victim 2, with a dangerous weapon, to-wit: .22 caliber pistol.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

---

Your complainant is a licensed peace officer employed by the Rochester Police Department. In that capacity your Complainant has reviewed the police reports relating to Jaeden Mikkel Adcox, the above-named defendant, and the allegations contained therein. Based upon that information, your complainant believes the following to be true and correct.

On November 14, 2019, at approximately 4:20 AM, officers of the Rochester Police Department were dispatched to 3955 18th Ave. NW on a report of a shooting incident. Once on scene Officer Matos determined there were two victims on scene, Victim 1 and Victim 2- both adult males fully identified in police reports. Officer Matos spoke with Victim 1. Victim 1 said he was inside his cousin's apartment at the address that evening. Later, Victim 1 left the apartment to go start Victim 2's car outside. While outside a male wearing a red coat and a black mask approached him. Victim 1 described the male as a light-skinned male. The suspect pulled a small handgun and put it to Victim 1's head. The male demanded Victim 1's money and Tramadol. Victim 1 said the suspect took 26 pills, but some spilled on the ground. The suspect also took \$165.00 in cash. Victim 2 came outside and Victim 1 told him that he was being robbed. The suspect then fired some shots in the air and fired approximately 2-3 times at Victim 2. Victim 2 was struck in the leg and Victim 1 was grazed at the ankle. Victim 1 said the suspect took his mask off during the interaction.

Officer Pearson spoke with Victim 2. Victim 2 said that the male suspect was in the apartment that he and Victim 1 were in prior to the shooting. Victim 2 described the suspect as white or Puerto Rican. Victim 2 said once outside the same male was wearing a black mask. Victim 2 saw the suspect holding a handgun which he described as silver and small enough to fit inside the width of a hand. Victim 2 did not believe the gun was real and when the suspect began cussing at him as he approached he did not think he would be shot. Victim 2 said he dared the suspect to shoot and was then struck in the leg with one shot.

While the victims were brought to the emergency department a K9 track began in the area of 31th St NW and 15th Ave NW. During the track officers located a red hooded puffy-style jacket behind a residence on 14th Ave NW. The jacket contained a black mask in the pocket. The track then continued to a residence on 30th Street NW. The K9 suddenly turned towards the deck of the residence. Officer Matz observed a male hiding under the deck. The male was commanded to crawl out from under the deck. The male was identified as Jaeden Mikkel Adcox (4/14/2001), Defendant herein. Officer Pretzloff, with the assistance of his K9 partner, located a small silver .22 pistol in vegetation behind a residence on 15th Avenue NW. A .22 casing was located at the scene of the shooting.

Inv. Valere conducted a follow up interview with Victim 1 and Victim 2. Victim 1 gave a consistent account to what he told patrol. Victim 1 also told Inv. Valere that he had thrown a rock at Defendant after he was shot and he struck him in the nose. Victim 1 said Defendant should have an injury to his face. Inv. Valere prepared a photo line up for both victims after Defendant was located and arrested. Both victims positively identified Defendant as the suspect who shot them.

Defendant declined to give a statement after his arrest. However, Inv. Valere did observe that Defendant had a severe bruise and a fresh cut on the bridge of his nose.

Defendant has an Extended Juvenile Jurisdiction conviction for Felony Assault in the 2nd Degree in 55-JV-18-6523 which disqualifies him from the use and possession of firearms.
