On or about June 1, 2020, within the County of Olmsted, Kaleb Wolfe Smith did wrongfully, unlawfully and feloniously cause the death of a human being, to-wit: Victim, without intent to effect the death of any person, while committing or attempting to commit a felony offense other than criminal sexual conduct in the first or second degree with force or violence or a drive-by shooting.

Domestic Assault by Strangulation

In Violation of: 609.2247 subd. 2

Penalty Statute:

609.2247 subd. 2 - Domestic Assault - By Strangulation

On or about June 1, 2020, in the County of Olmsted, Kaleb Wolfe Smith did wrongfully, unlawfully, and feloniously inflict or attempt to inflict bodily harm against a family or household member, to-wit: Victim, by intentionally impeding normal breathing or circulation of the blood by applying pressure on the throat or neck or by blocking the nose or mouth of another.

Statement of Probable Cause

Your complainant is a licensed peace officer employed by the Olmsted County Sheriff's Office. In that capacity, your complainant has reviewed police reports relating to the above-named defendant and the allegations contained herein. Based upon that information, your complainant believes the following to be true and correct:

On June 1, 2020, at about 4:39 p.m., Olmsted County Sheriff's Deputies were dispatched to a residence in the City of Eyota, Olmsted County, Minnesota, in response to a report of a medical emergency. Upon arrival, Deputy Salley saw Eyota Ambulance personnel attending to Victim (a child fully identified in police reports). Deputy Salley talked to Victim's mother, who reported having been away from the home for a short period of time, and reported that Victim's brother, Kaleb Wolfe Smith (date of birth: February 16, 2003) ("Juvenile"), had been with Victim in the house.

Victim was transported to Mayo Clinic Hospital Saint Marys Campus, and was pronounced dead at 5:57 p.m.

Deputy Salley talked to Juvenile, who acknowledged having been alone in the house with Victim, and reported that he had tucked Victim in for a nap by putting a blanket on Victim.

Detective Johnson conducted a follow-up interview with Juvenile at about 9:15 p.m. During that interview, Juvenile reported the following. Juvenile and his siblings had been attempting to nurse an injured bird back to health over the previous couple of days. Earlier in the day, Juvenile was inside the house, and several siblings came inside to tell Juvenile that Victim had killed the bird. Juvenile went to look for Victim, who was hiding under their mother's bed. Juvenile pulled Victim out from under the bed, and carried Victim to their mother. Victim was squirming, causing Juvenile to drop Victim. Their mother sent Victim upstairs to bed. Juvenile went into Victim's room a couple of minutes later, because Victim was crying and throwing a fit. Victim was kicking and hitting the bed, and "flopping like a fish." Juvenile stood to the side of Victim, and pinned Victim's hands to Victim's body to get Victim to stop flopping. Juvenile took a blanket, draped it over Victim's body and head, then went to his own room to read. Victim continued shrieking. Juvenile went back into Victim's room. Juvenile pinched Victim's nose shut, and put his hand over Victim's mouth for "one to two minutes" until Victim stopped shrieking.

On June 2, 2020, the Regional Medical Examiner's Office conducted an autopsy. Preliminary results of the autopsy indicated that Victim's brain exhibited swelling consistent with hypoxia by smothering.
