The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

**Charge: Attempted Murder in the First Degree**

Maximum Sentence: 20 years imprisonment

Offense Level: Felony

Offense Date (on or about): 11/29/2020

Charge Description: The defendant in Freeborn County, with intent to commit a crime, did an act which was a substantial step toward, and more than preparation for, the commission of the crime of murder in the first degree in that he did attempt to cause the death of a peace officer, prosecuting attorney, judge or a guard employed at a Minnesota state or local correctional facility, with intent to effect the death of that person or another, while the person was engaged in the performance of official duties.

#### STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your complainant is a Peace Officer employed by the Agency responsible for investigation of the abovenamed case. In that capacity your complainant has reviewed investigative reports relating to the abovenamed defendant and the allegations contained herein. Based upon that information, your complainant believes the following to be true and correct:

On 11/29/20 at approximately 0218 hours, Albert Lea Police officers responded to a call for assistance regarding a complaint of fireworks or gun shots fired in the area of the 800 block of 4th Avenue South, in Albert Lea, Freeborn County, Minnesota. The first responding squad was fired upon and the officer was hit. Later examination of his injury revealed a wound in the area of his chest which appeared about 2"x 2" and was consistent with a wound caused by a high velocity impact. He was wearing a protective vest. He was able to retreat and other officers surrounded Shady Oaks nearby.

Officers were ultimately able to determine that shots were being fired from Apartment 303 in the Shady Oaks apartment building. Over approximately the next 8 hours shots were periodically fired from the apartment while officers attempted to make contact with the individual.

A person (referred to here as Victim 1 to protect his privacy) heard noises and left the Shady Oaks building because he was concerned about his vehicle. As he returned to the apartment building, he was shot in the arm. A police officer rescued the man from the scene and took him to the hospital. He suffered an entrance wound in the rear of the right bicep, a larger hole on the front side which appeared to be an exit wound. His humerus appeared to have been fractured and displaced. There was also a large tearing injury to the right side of his chest.

A person (referred to here as Victim 2 to protect his privacy) who lives across the street from Shady Oaks left for work at approximately 5:15 hours. He drove north on 4th and was struck by a bullet through his car door. He suffered a penetrating injury to his leg which required emergency surgery.

Officers attempted to evacuate the building as the subject, later identified as the defendant named in this complaint continued firing at officers and residents. Most of the residents were removed to safety.

Three separate SWAT Teams were on scene and were engaged in a standoff with the defendant while he periodically fired at them out the window of apartment 303. Tear gas was deployed. The defendant fired rounds through his apartment door into the hallway. Ultimately the defendant suffered an injury to his forehead which bled heavily and he then came out of his apartment and surrendered to law enforcement officers who had positioned themselves in the apartment building to prevent his escape. He was arrested and transported to the hospital. The scene was secured pending processing by the Bureau of Criminal Apprehension.

After his release from the hospital the defendant was transported to the Freeborn County Adult Detention Center where he was interviewed by Special Agents Derek Woodford and Mike Anderson. He acknowledged that he had contacted law enforcement and made a report regarding gunshots or fireworks in the area. He acknowledged that he had fired at the squad car. He admitted that he had fired at another vehicle thinking that it was a squad car. He said that he thought that the police were going to take his guns. He admitted that he had fired about 75 rounds. He admitted shooting through his door because he thought that the police were assembled outside his apartment. He said that that's why he barricaded his door. He

said that he was sorry and that he wanted the agents to convey that to the multiple shooting victims involved 20 in this incident. He admitted that he had fired several shots at the armored vehicle that was used by law enforcement in this incident. He said that he was angry that they had used tear gas. The defendant admitted to getting his guns ready because he was concerned about a confrontation that night.

The crime scene was processed by the Bureau of Criminal Apprehension, and investigators estimate 90 rounds were fired. Firearms were seized from apartment 303 including three rifles and a shotgun.

NOTICE: FAILURE TO APPEAR FOR COURT WHEN REQUIRED TO DO SO IS A CRIMINAL OFFENSE UNDER MINNESOTA STATUTE 609.49. If you are charged with or have been convicted of a felony offense, an intentional failure to appear for a court appearance is a felony offense which is punishable by one-half of the statutory maximum term of imprisonment and fine for the underlying crime for which you fail to appear and is to be no less than one year and a day in prison and a \$1,500 fine. If you are charged with a gross misdemeanor offense or a misdemeanor offense, an intentional failure to appear for trial is a misdemeanor offense and may be punished by imprisonment for up to ninety days and a fine of up to \$1,000.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
