The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Aggravated Robbery-1st Degree

Minnesota Statute: 609.245.1, with reference to: 609.11.5(a)

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 08/27/2021

Control #(ICR#): 21036645

Charge Description: On or about August 27, 2021, in the County of Olmsted, Minnesota, Deonte Lemont Jenkins did having knowledge of not being entitled thereto, take personal property from the person or in the presence of another, to wit Victim, and used or threatened the imminent use of force against any person to overcome the person's resistance or powers of resistance to or compel acquiescence in the taking or carrying away of the property, and while committing the robbery was armed with a dangerous weapon or an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon,.

COUNT II

Charge: Criminal Sex Conduct-2nd Degree-Armed w/Dangerous Weapon

Minnesota Statute: 609.343.1(d), with reference to: 609.11.5(a), 609.343.2(a), 609.343.2(b)

Maximum Sentence: 25 years or \$35,000 fine or both

Offense Level: Felony

Offense Date (on or about): 08/27/2021

Control #(ICR#): 21036645

Charge Description: On or about August 27, 2021, in the County of Olmsted, Minnesota, Deonte Lemont Jenkins did engage in sexual contact with another person, and was armed with a dangerous weapon consisting of a gun or an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon and used or threatened to use the weapon or article to cause the victim to submit,

COUNT III

Charge: Burglary-1st Deg-Poss Dangerous Weapon/Explosive

Minnesota Statute: 609.582.1(b), with reference to: 609.11.5a, 609.582.1

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 08/27/2021

Control # (ICR#): 21036645

Charge Description: On or about August 27, 2021, in the County of Olmsted, Minnesota, Deonte Lemont Jenkins did enter a building without consent of the lawful possessor with intent to commit a crime or committed a crime while in the building, either directly or as an accomplice, and possessed a dangerous weapon or an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon when entering or while in the building

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your complainant is a licensed peace officer employed by the Rochester Police Department. In that capacity your Complainant has reviewed the police reports relating to DEONTE LEMONT JENKINS (5/29/81), the above-named defendant, and the allegations contained therein. Based upon that information, your complainant believes the following to be true and correct.

On Sunday, August 29, 2021 at 12:50 p.m., officers from the Rochester Police Department responded to a call for serve related to an incident that occurred from approximately 4:30 p.m. on Friday, August 27, 2021 to 8:00 a.m. on Saturday, August 28, 2021. The reporting party (an adult female hereinafter "Victim") was reached via telephone by Ofc. Erickson.

Victim reported that she is not from Southeast Minnesota and visits Rochester for medical appointments. From August 26 to August 28, 2021, Victim stayed at a Rochester hotel. On August 27 (Friday), Victim finished her last procedure at approximately 4:30 and returned to the hotel. There, Victim saw an adult male standing outside the stairwell entrance. Believing the male suspect was another guest of the hotel, Victim walked past him to go inside the building. Once Victim opened the door, the male suspect followed behind her. Victim did not feel comfortable, so she slowed down to allow the male suspect to go ahead of Victim. However, when Victim slowed down, so did the male suspect. The male suspect followed Victim up four flights of stairs and the male suspect continued to follow her. At some point, the male suspect told Victim that they were out of the camera view and that he had a gun. The male suspect also told Victim to follow his rules. Once Victim arrived at her hotel room, the male suspect made Victim open the door and he barged in with Victim.

According to Victim, once inside the room, the male suspect pulled out a handgun and pointed it at Victim. At first, the male suspect seemed concerned about getting Victim's money. The male suspect took \$80 cash, Victim's driver's license and her credit cards. The male suspect photographed Victim's credit card and driver's license and then used Victim's mobile device to send himself a text message (so that the male suspect had Victim's phone number). Then, the male suspect used Victim's mobile device to attempt to wire himself money. The male suspect tried to wire himself multiple times in the amounts of \$500 and \$1000. The male suspect became increasingly upset because the transactions were not working and began to threaten Victim.

Victim told Ofc. Erickson that the male suspect told Victim to do what he wanted or he would kill her. At gunpoint, the male suspect made Victim call the bank and tell them the transactions were valid. The male suspect also told Victim that he was getting an erection and that Victim needed to "take care of it." Victim begged the male suspect to not sexually assault her and asked the male suspect to leave multiple times. At one point, Victim brought up the police and the male suspect stated something to the effect of, "I don't think you understand. You do that and you're dead." The male suspect told Victim that he was from Atlanta and had six kids. The male suspect also told Victim that he and his associates conduct illegal activities out of the hotel they were in and another downtown Rochester hotel.

According to Victim, the male suspect kept showing her his penis and kept trying to get Victim to touch the male suspect's penis. At one point, the male suspect grabbed Victim's hand and placed it on his penis, over his clothing. Victim quickly moved her hand away. Eventually, the male suspect gave up on sexually assaulting Victim and left the hotel room. It was about 2:00 a.m. on August 28, 2021. Shortly after his departure, the male suspect sent Victim messages saying that his account was locked and that he had drug deals to take care of. The male suspect returned to Victim's room after about ten minutes. Finally, the male suspect left again. However, the male suspect called Victim repeatedly and sent her text messages to open the door. Eventually, Victim checked out and left the hotel.

When the male suspect was using Victim's phone and accounts, he used the names "Hikeem Yursun" and "Deonte." Victim used those names to search social media and found a photograph of DEONTE LEMONT JENKINS (DOB 5/29/81). According to Victim, she is 100% certain of the identification, partly due to the distinctive "GA" tattoo under JENKINS's eye and a cross tattoo on his arm.

Ofc. Erickson recognized JENKINS's name from a call he had taken at the other hotel that JENKINS referenced when

describing his criminal activity to Victim. The call at the other hotel involved a suspected fraud and JENKINS applying for a job. On the application, JENKINS provided his name, phone number and email. JENKINS's email contained the name "Hikeem Yursun."

Ofc. Erickson also spoke to the manager of the hotel at which the incident occurred. The manager confirmed that Victim was frantic to leave on the morning of Saturday August 28th. Around 8:00 a.m., Victim was frantic to get a taxi or an Uber and asked if somebody from the hotel would be able to escort Victim out to the car when it arrived. Victim also mentioned receiving threats, but didn't give details. The hotel manager had an employee escort Victim from her room down to the lobby. The hotel manager showed that Victim's room was entered at 4:41 p.m. on Friday the 27th (consistent with her version of events). Ofc. Erickson also reviewed surveillance video. On the video, Victim can been seen approaching the exterior door at 4:32 p.m. Victim can be seen hesitating and a male matching JENKINS's general description enters the hotel with Victim. Victim and JENKINS awkwardly pause at the bottom of the stairs before walking up the stairs.

On August 29, 2021, at 6:15 p.m., Ofc. Herman observed JENKINS walking toward the officer on Third Street SW. JENKINS was with an elderly white male. Ofc. Herman observed JENKINS to have the same tattoos and gold teeth as the description given by Victim. Upon arrest, JENKINS stated that his name was "Hikeem Yursun."

Ofc. Prink interviewed JENKINS following the administration of the Miranda warning. JENKINS stated that he was from Atlanta, Georgia and was in Rochester visiting his children and their mother, Teonna Gayles. At first, JENKINS denied going to Victim's hotel and stated that he never met a woman. JENKINS confirmed that his Facebook account was under the name "Hakeem Yursun." Later, however, JENKINS admitted that he met a female near a hotel, but claimed that they parted ways and "that was it." Then, JENKINS amended his version of events and admitted that they went to a hotel room, but that nothing sexual occurred.
