The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(3)(d)(v) Maximum Sentence: Up to five years imprisonment and/or \$10,000 fine.

Offense Level: Felony

Offense Date (on or about): 07/24/2021

Control #(ICR#): 21102832

Charge Description: That the defendant, Benton Louis Beyer, then and there being, did wrongfully, unlawfully and intentionally and without claim of right take, use, transfer, conceal or retain possession of moveable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property and the property is a motor vehicle.

COUNT II

Charge: Stalking - Engages in Stalking

Minnesota Statute: 609.749.5(a), with reference to: 609.749.5(a)

Maximum Sentence: Up to ten years imprisonment and/or \$20,000 fine.

Offense Level: Felony

Offense Date (on or about): 07/14/2021 to 07/25/2021

Control #(ICR#): 21102832

Charge Description: That the defendant, Benton Louis Beyer, then and there being, did wrongfully and unlawfully engage in stalking with respect to a single victim or one or more members of a single household which the actor knows or has reason to know would cause the victim under the circumstances to feel terrorized or to fear bodily harm and which does cause this reaction on the part of the victim, to-wit: HRO violations within the last five years.

COUNT III

Charge: Damage to Property - 1st Degree - Foreseeable Risk Bodily Harm

Minnesota Statute: 609.595.1(1), with reference to: 609.595.1

Maximum Sentence: Up to five years imprisonment and/or \$10,000 fine.

Offense Level: Felony

Offense Date (on or about): 07/24/2021

Control #(ICR#): 21102832

Charge Description: That the defendant, Benton Louis Beyer, then and there being, did wrongfully, unlawfully and intentionally cause damage to physical property of another without the latter's consent and the damage to the property caused a reasonably foreseeable risk of bodily harm.

COUNT IV

Charge: Harassment; Restraining Order - Violate Restraining Order

Minnesota Statute: 609.748.6(a), with reference to: 609.748.6(c) Maximum Sentence: Up to one year in jail and/or \$3,000 fine.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/24/2021

Charge Description: That the defendant, Benton Louis Beyer, then and there being, did wrongfully and unlawfully violate a restraining order within ten years of a previous qualified domestic violence-related offense conviction, to-wit: a conviction for Assault in the Second Degree in Stearns County District Court File No. 73-CR-11-2631 on September 14, 2012.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

On July 24, 2021 at approximately 5:30 AM, law enforcement responded to a stolen vehicle report at a residence located on the 300 block of 3rd Avenue South in the City of Cold Spring, County of Stearns, State of Minnesota. M.E.H., adult male fully identified in the police reports, reported his vehicle had just been stolen and he believed it was stolen by Benton Louis Beyer, DOB: 12/26/1988, the defendant herein. M.E.H. explained the defendant had stolen his keys a couple of weeks prior and never returned them. M.E.H. stated he heard his vehicle start and immediately went outside. He saw his vehicle backing out of his driveway and he was "pretty sure" the person he saw in the driver's seat was the defendant.

Minutes later, at 5:35 AM, dispatch received a report of a vehicle that had crashed into a residence located on the 600 block of Emma Drive SE in the City of Cold Spring, County of Stearns, State of Minnesota. Officers responded to the residence and observed M.E.H.'s vehicle crashed into the residence. It was unoccupied and had a large piece of granite sitting on the accelerator. Officers spoke with A.G.R., adult female fully identified in the police reports, who owns the residence. A.G.R. provided Ring doorbell surveillance footage of the crash. The footage shows M.E.H.'s vehicle stopped at an intersection across the street from A.G.R.'s residence. A person dressed in a black shirt and lighter colored shorts then gets out of the driver's seat of the vehicle and runs into a field nearby. The vehicle proceeds forward until it crashes into the front of A.G.R.'s residence.

Officers attempted to search the field for the suspect but the field was extremely wet and difficult to navigate through so the search was terminated.

The crash caused extensive damage to A.G.R.'s residence including damage to the siding, sheet rock, property around the interior and exterior of the residence and potentially the roof. The impact of the crash was so strong that it moved a vehicle inside if A.G.R.'s garage.

A.G.R. reported her residence was occupied at the time of the crash and that one of her children was sleeping on the couch in the living room at the time of the crash. The living room is just a short distance away from where the vehicle crashed into the front of the residence.

A.G.R. reported she believed it was the defendant who crashed the vehicle into her residence and that she is "terrified" of him. A.G.R. explained there is an active Harassment Restraining Order ("HRO") in place protecting her from the defendant. A HRO was issued on May 21, 2021 in Stearns County District Court File No. 73-CV-21-3370 prohibiting the defendant from having any direct or indirect contact with A.G.R. for two years.

Officers reviewed recent history and learned of 18 calls within the past two months regarding the defendant stalking and harassing A.G.R. Most recently, the defendant was arrested on July 15, 2021 in the City of Waite Park, County of Stearns, State of Minnesota, and released from custody on July 19, 2021, for an incident (documented in Stearns County District Court File No. 73-CR-21-4906) where he is alleged to have been following/stalking A.G.R. in violation of the HRO.

Officers located the defendant's maroon Dodge Spirit at the Cold Spring Park and Ride which is only one half mile from A.G.R.'s residence. Officers also located the defendant's other vehicle, a Chevy Blazer, at Cold Spring Lions Park which is only one block away from where M.E.H.'s vehicle was stolen.

Officers located the defendant at 10:00 AM walking near Alexander Park in the City of Cold Spring, Country of Stearns, State of Minnesota. The defendant was wearing a black shirt and was soaking wet.

The defendant has a prior qualified domestic violence-related offense conviction for Assault in the Second Degree in Stearns County District Court File No. 73-CR-11-2631 for which he was convicted on September 14, 2012.

Complainant has reason to believe and does believe that all of the above information is true and correct.

The above facts constitute your complainant's basis for believing that the above-named defendant, on or about the 24th day of July, 2021, in the City of Cold Spring, County of Stearns, State of Minnesota, committed the offense(s) described herein.
