St. Cloud Area School District Responds to Change in SRO Agreement

Today local law enforcement agencies announced their intention to indefinitely suspend the Joint Powers Agreement (JPA) with St. Cloud Area School District 742 in regard to School Resource Officers (SRO) for the 2023-24 school year. The decision comes in response to recent changes in state statute.

Like many districts across Minnesota, District 742 has formal agreements with local police departments, specifically St. Cloud, St. Joseph and Waite Park, that provide School Resource Officers located inside the schools. The primary role of these specially trained officers is to protect students and staff during the school day and often during school-sponsored events on evenings and weekends. Additionally, they often teach students about personal safety, mentor and support students, and assist with community-related safety issues.

"In the Greater St. Cloud Area, our relationships with local police departments have existed for many years," says Superintendent Laurie Putnam, "and we greatly appreciate and value the support our School Resource Officers provide."

Regarding the change, Putnam emphasizes, "our mutual commitment to school safety remains," while acknowledging that going forward support from law enforcement in the schools will look different.

Law enforcement personnel will be present during the school day and at public school-sponsored evening and weekend events when it is determined there is a need for public-safety support. However, officers will likely be in full uniform and no longer engage in educational programming.

Putnam reminds families that safety in the schools requires a multi-faceted approach including mutual commitment to building strong relationships by staff, students and families as well as strategies that focus on the buildings and grounds, such as controlled and monitored entrances, locked doors, the screening and monitoring of visitors and supervision throughout the schools.

"Along with local law enforcement, our priority is student and staff safety," Putnam says. "That has not, and will not, change."
