

## Breeze Airways Giveaway FLYAWAY RULES

Sweepstakes Name: "Breeze Airways Giveaway: Win a Trip and Hotel Stay"

Townsquare Media Portland, LLC, its parent company and affiliated companies (together, the "Company" or "Contest Organizer"), will conduct the Sweepstakes substantially as described in these rules, and by participating, each participant agrees as follows:

The Company may conduct the Sweepstakes concurrently and simultaneously on several participating stations owned and or operated by the Company and/or owned and operated by other companies, and in various states, and the Company may add or remove participating stations or change call letters of any participating station at any time during the Sweepstakes as announced on the affected station. ### 1. Eligibility.

The sweepstakes is open to legal residents of Alabama, Arkansas, Arizona, Colorado, Connecticut, Idaho, Illinois, Indiana, Iowa, Kentucky, Louisiana, Maine, Massachusetts, Michigan, Minnesota, Missouri, Montana, New Hampshire, New Jersey, New Mexico, New York, North Dakota, Oklahoma, Oregon, Pennsylvania, South Dakota, Texas, Utah, Vermont, Washington, Wisconsin, and Wyoming who are at least 21 years old as of the date of entry. Employees of Breeze Airways, Contest Organizer, its affiliated radio stations and their respective affiliated and subsidiary companies, partners and members of the immediate families or households of such employees ("Excluded Individuals") are not eligible. Additionally, immediate family members of the Excluded Individuals are not eligible to participate in the Contest. For the purpose of these Official Rules, "immediate family" includes: father, mother, brothers, sisters, children, legal or common-law spouse and individuals with whom such employees, agents and representatives reside. Void where prohibited.

### 2. How to Enter:

Beginning 12:01 p.m. (local time) on August 11, 2026, and continuing through 11:59 p.m. (local time) on August 26, 2026 ("Sweepstakes Entry Period"), Participants should visit the WJBQ sweepstakes entry page (<https://wjbq.com/contests>) and/or the WBLM sweepstakes entry page (<https://wblm.com/contests>). Participants will be asked to provide their personal information (name, email, telephone) and be prompted to take further action, which may include, for example, visiting the station's Facebook page, joining the station's mailing list, subscribing to

the station on YouTube, following the station on Twitter/X, sharing links to the sweepstakes on social media, and visiting advertiser websites. Completion of the above steps (registration and further action) will earn you one (1) entry into the grand prize drawing ("Grand Prize Entry").

### 3. Terms of Entry:

No purchase necessary. Completion of the above steps will enter you into a random drawing for your chance to win the Grand Prize, as defined below. Participants may enter on both Stations but may only win one (1) Grand Prize. Only one Grand Prize Entry per person, per Station, will be valid during the sweepstakes, regardless of which action they take as directed by the contest page. All Grand Prize Entries must be submitted and received no later than 11:59 p.m. local time on August 26, 2026. Odds of winning depend on the number of entries received. Entry/registration does not guarantee a prize.

The use of any agencies or automated software to submit entries will void all entries submitted by that person. Irregularities in the entry process will be investigated by Contest Organizer and may result in disqualification. Any decision made by Contest Organizer as a result of any such investigation shall be final.

### 4. Winner Selection:

On August 27, 2026, after conclusion of the Sweepstakes Entry Period, Contest Organizer will select two (2) Grand Prize Winners: one (1) Grand Prize Winner selected at random from all Grand Prize Entries received through the WJBQ entry page, and one (1) Grand Prize Winner selected at random from all Grand Prize Entries received through the WBLM entry page.

Each Grand Prize Winner will be notified by phone or email that they have been randomly selected as a Grand Prize Winner of this Contest. If chosen as a Grand Prize Winner, entrant must return the station's call or email within 48 hours or risk forfeiture of the Grand Prize. If station is unable to connect with a Grand Prize Winner within 48 hours, Company reserves the right to choose an alternative Grand Prize Winner. In this event, the alternative Grand Prize Winner will also be selected at random from the collective pool of all remaining and valid Grand Prize Entries for the applicable Station.

### 5. Prize Description:

Each Grand Prize shall be defined as round trip Nice Bundles on Breeze Airways for two (2) people (Grand Prize Winner + one guest) from Portland International Jetport (PWM) in Portland, Maine, to Sarasota Bradenton International Airport (SRQ) in Sarasota, Florida; and a \$2,000 credit toward hotel accommodations at Palmetto Marriott Resort & Spa in Sarasota, Florida (collectively, the "Grand Prize"). The approximate retail value of the airfare is \$400. The approximate retail value of the hotel credit is \$2,000. Grand Prize Winner is responsible for any hotel charges exceeding the \$2,000 credit.

**Approximate retail value of each Grand Prize is \$2,400. Approximate total retail value of all Grand Prizes combined is \$4,800.**

## 6. Prize Terms:

A. **Travel Terms.** Airfare is provided by Breeze Airways. Grand Prize Winner will receive an email from Breeze Airways containing a link to book two (2) "Nice" bundles for roundtrip travel for Grand Prize Winner and one (1) travel companion from PWM to SRQ. Any additional amenities will be available to purchase at an additional cost. The designated companion must be at least eighteen (18) years of age or older. The winner must travel with their designated companion on the same flight. Standard seating is subject to availability on all flights requested. BreezePoints will not be earned on the "Nice" bundles. The actual value of the "Nice" bundles will depend on the selected departure dates. The winner will not be awarded any difference between the actual and estimated retail value of their prize, if any. Once a "Nice" bundle is reserved, changes cannot be made to reserved travel without the approval of Breeze Airways, in its sole discretion.

Travel restrictions, conditions and limitations may apply. Travel on Breeze is subject to space availability and blackout dates. All travel is subject to the Breeze Contract of Carriage. Contest Organizer and Released Parties are not responsible for flight cancellations, weather conditions or any other circumstance beyond its control, or for inability of winner to travel in accordance with these Official Rules or the Breeze Contract of Carriage. Winner is responsible for booking any transportation or other products or services associated with the redemption of Breeze Airways™ flights. All other expenses and costs not expressly stated in the applicable prize description above including, but not limited to, transportation between a winner's home and the airport, ground transportation, lodging, meals, beverages, incidentals, taxes, passenger tariffs or duties, surcharges, airline or airport fees, service charges, security fees, facility charges, gratuities, optional excursions and purchases made in connection with the redemption of Breeze Airways™ flights are solely the winner's responsibility. Grand Prize excludes flights departing during the following blackout periods: September 3, 2026 through September 7, 2026; November 19, 2026 through November 30, 2026; and December 17, 2026 through January 5, 2027.

No cash substitute will be provided for airfare. Grand Prize Winner shall be responsible for any upgrades to their travel bundle, if any.

B. **Hotel Accommodation.** Hotel accommodation is provided by Palmetto Marriott Resort & Spa. Contest Organizer will provide Grand Prize Winner with a winner's certificate. Hotel must be booked by August 31, 2027. There are no blackout dates for hotel accommodation. No cash substitute will be provided for hotel accommodation. Grand Prize Winner shall be responsible for any upgrades to their hotel accommodation, if any, including any expenses that exceed the \$2,000 prize value. Grand Prize Winner is responsible for transportation to/from airport, including any additional transportation required upon arrival in Sarasota, Florida. Additional expenses to be covered by Grand Prize Winner.

Multiple entries on the same Station will not increase your chance of winning. Multiple entries on the same Station will not be accepted. Odds of winning a prize depend on the number of eligible entries with respect to the applicable Station's drawing.

Grand Prize Winner will be required to fill out all applicable paperwork (including verification of eligibility and a liability and publicity release). If applicable, Grand Prize Winner must claim his/her prize from the Company, as noted above in section 4 of these rules, within 48 hours from the station's call or email notifying Grand Prize Winner that he/she has won the contest. Failure to claim the Grand Prize may result in forfeiture of the Grand Prize. In the Company's discretion, Grand Prize Winners may be required to receive the Grand Prize (or portions of the Grand Prize, if applicable) via mail, to pick up the prize at the participating stations, or to receive the prize via another method specified by the Company. Company reserves the right to refuse to award a prize to a selected winner in the event of noncompliance with these rules. All winners are subject to a verification process to include winner's name, address, home phone number, work/cell phone number, and social security number. If a winner is disqualified, Company reserves the right to determine an alternate winner in its sole discretion. Only one (1) prize can be claimed per household for the duration of the Sweepstakes. **Winners are eligible to win only once per twelve (12) month period in any Townsquare Media Inc. nationwide and/or group contest or sweepstakes.** Employees of the Company, the Sweepstake's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The Company is not responsible for human, mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the Sweepstakes, and any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Sweepstakes.

#### 10. Publicity; Use of Personal Information.

By participating, all participants and winners grant the Company permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other sweepstakes, participating station(s) and participating sponsor(s), and waive any claims to royalty, right, or remuneration for such use. By participating in the Sweepstakes, participants agree that the Company may disclose personal information obtained from participants in the Sweepstakes to third parties, including Breeze Airways, and for Company and third parties to use such information for marketing and other purposes on a worldwide basis in perpetuity in accordance with their respective privacy policies. #### 11. Release and Indemnity.

Any person winning over \$600 in a single or collective prize(s) from the Stations will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.

## 13. Conduct and Decisions.

By participating in the Sweepstakes, participants agree to be bound by the decisions of Company, which are final and binding. Persons who violate any rule, gain unfair advantage in participating in the Sweepstakes, or obtain winner status using fraudulent means will be disqualified. The Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Sweepstakes and the Company's decisions concerning such disputes shall be final and binding.
