

Bill Dodge Auto Group \$25,000 Score Prediction Challenge

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING CONTEST IS VALID ONLY IN MAINE, MASSACHUSETTS, NEW HAMPSHIRE, VERMONT, AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED. Contest Dates: Contest registration is scheduled to begin on **9/4/2024** and end on **1/4/2025** (the "Registration Period"). The grand prize contest will occur during each designated **2024 Professional Football New England Regular Season game** beginning on **9/8/2024** and ending on **1/5/2025**. The contest is subject to all applicable federal, state and local laws and regulations and is void outside Maine, Massachusetts, New Hampshire, and Vermont, and wherever prohibited or restricted by law.

Who May Enter: Contest is open to legal U.S. residents, of MA, ME, NH, or VT and who are age 18 or older as of date of entry, and have a valid U.S. driver's license, except the following classes of persons who are not eligible to enter:

Each participant must submit an entry on their own behalf. No person may enter more than the stated number of times as outline above in each registration method and no person may enter on behalf of another individual, or in another person's name. Any person found in violation of this provision will be disqualified and all entries submitted by that person will be ruled ineligible for any prize award.

Sponsor and their respective subsidiaries and affiliates are not responsible for lost, late, incomplete, stolen, misdirected, illegible entries; for any entry not submitted in a manner as required by these contest rules, or not received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer transmissions and/or network connections.

In the event of a dispute as to any registration or play, the authorized account holder of the e-mail address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries become the property of the Sponsor and will not be returned.

Any available opt-in opportunities are not required to enter the Contest, and checking the opt-in boxes will not improve your chances of winning. By participating and submitting an entry, contestant agrees that sponsors and participating parties are authorized to contact entrant via email, mail, phone or any other form of media to make contestant aware of information pertinent to the contest, and to distribute information regarding the Sponsor(s), upcoming contests, promotions, special events or offers, or other sales or discount offers. Finalist Selection & Notification: A random drawing will be held at the conclusion of each Entry Period during the from among all eligible entries received during the corresponding Entry Period to select one (1) official finalist (each a 'Finalist'). A selected Finalist who does not meet the eligibility requirements, does not wish to participate in the grand prize contest will be disqualified. An alternate Finalist will be randomly selected per the procedures outlined above, time permitting. Decisions of judges in the selection and determination of the Finalist, and all matters related to this contest are final.

Only the selected Finalists will be eligible to participate in the grand prize contest for the chance to win the grand prize (*described below*). All other entrants are ineligible to participate or win. Finalist selection and participation is non-transferable.

Score Prediction Contest: In order for the grand prize to be awarded to a Finalist, the **Halftime AND Final Score prediction** submitted by that Finalist for their assigned game must exactly match the **actual Halftime AND Final Score** of the designated game they were required to predict according to the following requirements:

- All Halftime AND Final Score predictions must be completely accurate and match the exact score with the correct team. For example, if the actual final score of a designated game is New England - 27, Miami - 10, then a predicted final score of Miami - 27, New England - 10 or a final score prediction of 27 – 10 without specifying the associated teams will not constitute a winning entry.
- All entries must be clear, legible and complete for each team. Any unclear or incomplete predictions will be disqualified and will not be eligible for any prize award.
- Only the one (1) Finalist selected by Station for a designated game is eligible to participate or win for their assigned game. All other consumers who submitted an entry for the designated game are disqualified and will not be eligible to participate or win, regardless of the accuracy of their prediction.
- The **grand prize** will only be awarded to a Finalist if BOTH their halftime AND final score prediction exactly matches the actual Halftime AND Final score of the designated game for BOTH teams.

Prize Awards & Delivery: In the event of a successful halftime and final score prediction, the Finalist who submitted the winning prediction will be eligible to claim the grand prize, subject to approval and verification of compliance with these official rules. The grand prize is: **\$25,000 towards the purchase of a vehicle at Bill Dodge Auto Group.**

Winner must accept delivery of vehicle from the sponsor designated dealer, or as otherwise specified by Sponsor. Sponsor will solely designate and specify available vehicle including make, model, color and options for Grand Prize winner's prize award. Grand Prize winner may not substitute, exchange, or apply the vehicle's value towards a higher cost or alternate vehicle. Designated vehicle must be the Sponsor designated vehicle that is currently in designated dealer's stock of inventory. Administrator reserves the right to award an alternate year model (i.e. 2023), if the 2024 model is not available at the time of prize award.

If the designated prize vehicle MSRP is under \$25,000, the winner will not be awarded the difference between the vehicle's actual MSRP and \$25,000. Grand Prize winner is responsible for paying any and all sales tax on prize award at time of delivery, estimated at approximately \$1,500 (based on a 6.0% tax value) but may vary depending on the state and county in which the vehicle is awarded.

All other costs and expenses related to prize acceptance and use not specified herein as being provided are the sole responsibility of Grand Prize winner, including but not limited to tax, title, insurance, license and registration fees. All income, federal, state and local taxes are Grand Prize winner's sole responsibility. The contest will be concluded following the first two successful halftime & final score prediction attempts. If the prize-winning requirements are not successfully completed by any Finalist during the contest period, then the contestant prize(s) **will NOT be awarded.**

All prize winner(s), if any, must accept delivery of prize from Sponsor, or as otherwise instructed by sponsor. All other costs related to prize delivery and acceptance are the responsibility of winner including but not limited to taxes, title, insurance, license, and registration fees.
