

**TOWNSQUARE MEDIA, INC.**  
**Radio Contest**  
**Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.**

**A purchase or payment will not improve your odds of winning.**

**THE PROMOTION:** The Shark Party and Flyaway to Vegas (the “Promotion”) will begin on March 9, 2020 at 12 A.M. EST and end on March 31, 2020 at 11:59 P.M. EST (“Promotion Period”). Odds of winning depend upon the number of eligible Entries (as defined below) received. Promotion is subject to all applicable federal, state and local laws. Void where prohibited.

**ELIGIBILITY:** The Promotion is open only to legal United States (“U.S.”) residents of the FCC designated signal area of WSHK (For designated signal area of WSHK log on to **radio-locator.com**, enter WSHK into the “Find US radio by call letters” box and the Coverage Map will be available to view) (“Designated Signal Area”) who are at least twenty-one (21) years old as of the start of the Promotion Period. Void outside Designated Signal Area, in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions, and where prohibited by law. Officers, directors, and employees of Promotion Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Promotion. Promotion Entities, as referenced herein, shall include Townsquare Media Portsmouth, LLC, (“Sponsor”), The Brook in Seabrook, New Hampshire (“The Brook”), WSHK and their respective parent, subsidiary, and affiliate companies, and their administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Promotion.

**HOW TO ENTER:**

You may enter the contest on the station site ([shark1053.com](http://shark1053.com)) on the contest page for The Shark Party and Flyaway to Vegas by completing the actions shown in any of the “multiplier” buttons on the page.

You may also enter the contest on air by calling in to the radio station (WSHK), to the number provided on air, during the morning show (5:30-9:00 a.m. Eastern Time) when the show announces a call-in segment to gain entry, and being the designated caller (for example the 5<sup>th</sup> caller) announced by the radio announcer.

All entries must include all information requested by the online form or station phone operator, as applicable.

Multiple entries are permitted during the Promotion Period. In the event that the selected caller is disconnected or is found to be ineligible by Sponsor in its sole discretion, the next eligible caller that successfully makes it through on the call-in line and completes their call and any on-air requirements as described above, as determined by Sponsor in its sole discretion, will be the potential winner (defined below). Entry constitutes permission (except where prohibited by law) to use entrant's name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval.

**WINNER SELECTION AND NOTIFICATION:** On or about the week of March 30, 2020, sixty (60) winners (each a "Winner") will be selected and notified via given phone number or given email address after being recognized as the designated caller and after accurately fulfilling the broadcast requirement as a condition of winning as described above. Potential Winners must continue to comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. There will be a total of sixty (60) Winners during the Promotion Period. Potential Winners may be required to sign and return to Sponsor, an affidavit of eligibility, liability and publicity release (except where prohibited) and a tax acceptance form (collectively, "Promotion Documents") within four (4) days of the date notice is sent, if applicable. Noncompliance within the stated time period will result in disqualification, and, at Sponsor's sole discretion an alternate potential Winner may be selected from the remaining eligible Entries. If any potential Winner cannot be reached, is found to be ineligible, cannot or does not comply with these Official Rules, or if any Prize (as defined below) or prize notification is returned as undeliverable, such potential Winner will be disqualified and time permitting, at Sponsor's sole discretion, an alternate potential Winner may be selected from the remaining eligible Entries. Limit   1   grand prize per family or household.

**PRIZES:** There will be a total of   61   Prizes (as defined below) awarded.

Total Approximate Retail Value of all potential prizes is   \$5,200  .

Sixty (60) people will win entry to the Shark Party at The Brook in Seabrook, New Hampshire (the "First Prize"), and they will each be permitted to bring one (1) guest.

One (1) grand prize winner, who will be selected randomly from the First Prize winners, will win the following (the "Grand Prize"):

- Roundtrip coach economy airfare for two (2) from Boston Logan International Airport in Boston, Massachusetts, or Manchester-Boston Airport in Manchester, New Hampshire, to McCarran International Airport in Las Vegas, Nevada.
- Two (2) nights hotel stay at the Eureka Casino Resort in Mesquite, Nevada

- Two (2) nights hotel stay at the Golden Nugget in Las Vegas, Nevada
- Transportation provided (which may be in the form of a rental car) from McCarran International Airport to Eureka Casino Resort in Mesquite, Nevada; from Mesquite, Nevada, to Golden Nugget in Las Vegas, Nevada; and from Golden Nugget, in Las Vegas, Nevada, to McCarran International Airport
- \$150 food credit at the Eureka Casino - to be used in any restaurant establishments on the Eureka Casino property
- \$100 in free slot play at the Eureka Casino

The First Prizes and Grand Prize are referred to collectively as the “Prizes” and each is a “Prize”. First Prize Winners are not required to attend the Shark Party at The Brook in Seabrook, New Hampshire, in order to be eligible to win the Grand Prize. All details of the Prizes will be determined by Sponsor in its sole discretion. Sponsor reserves the right to substitute a similar prize (or prize element) of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of any Prize are the sole responsibility of Winners. For any Prize with an ARV of six hundred dollars (\$600) or greater, Sponsor will furnish an Internal Revenue Service Form 1099 to Winner for the ARV of Prize for the year in which Prize was won. Prizes are subject to certain terms and conditions.

Prize cannot be transferred by Winners or redeemed for cash and is valid only for the items detailed above, with no substitution of Prize by Winners. If any Prize is unclaimed within a reasonable time after notification from Sponsor, as determined by Sponsor in its sole discretion, it will be forfeited, and time permitting, an alternate Winner may be selected from the remaining eligible Entries at Sponsor’s sole discretion.

For the Grand Prize, if hotel room (at Eureka Casino Resort or the Golden Nugget) is not available, an effort will be made to book the Nevada trip on dates requested by the Winner, but the dates will ultimately be determined by the Sponsor and are subject to availability.

Failure to comply with these conditions may result in disqualification from the Promotion at Sponsor's sole discretion.

**ADDITIONAL TERMS:** Sponsor reserves the right to permanently disqualify from any promotion any person they believe has intentionally violated these Official Rules. Any attempt to deliberately damage the Promotion or the operation thereof is unlawful and subject to legal action by Sponsor, who may seek damages to the fullest extent permitted by law. The failure of Sponsor to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsor (excepting compliance with applicable codes and regulations), or other "force majeure" event will not be considered a breach of these Official Rules. Released Parties assume no responsibility for any injury or damage to entrants' or to any other person's computer relating to or resulting from entering or downloading materials or software in connection with the Promotion. Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Sponsor reserves the right to cancel, modify, or suspend the Promotion or any element thereof (including, without limitation, these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules). In the event of cancellation, modification, or suspension, Sponsor reserves the right to select Winners in a random drawing from among all eligible, non-suspect Entries received prior to the time of the event warranting such cancellation, modification, or suspension. Notice of such cancellation,

modification, or suspension will be posted on the Website. Sponsor may prohibit any entrant or potential entrant from participating in the Promotion, if such entrant or potential entrant shows a disregard for these Official Rules; acts with an intent to annoy, abuse, threaten, or harass any other entrant, Sponsor, or Sponsor's agents or representatives; or behaves in any other disruptive manner (as determined by Sponsor in its sole discretion). Sponsor reserves the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Promotion.

**DISPUTES:** Except where prohibited by law, as a condition of participating in a Promotion, Entrant agrees that (1) any and all disputes and causes of action arising out of or connected with a Promotion, including but not limited to Prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the Judicial Arbitration and Mediation Services, Inc. ("JAMS") and held at the JAMS regional office nearest the Entrant. The Promotion is governed by, and will be construed in accordance with, the laws of the State of New Hampshire.
