

CARDI'S RE-DO A ROOM FOR THE HOLIDAYS
ON-AIR CONTEST RULES
Townsquare Media WOKQ-FM

1. How to Enter the Contest:

- a. The **CARDI'S RE-DO A ROOM FOR THE HOLIDAYS** ("Contest") will run from Monday October 1st 2018 through Friday October 19th 2018 by WOKQ-FM ("Station").
- b. To participate in the Contest, listeners must qualify on-air when prompted. The 'prompt' will be when the Cardi's Re-Do Artist of the Day is played. The correct caller will be added to that week's (M-F) pool of qualifiers. Station is not responsible for any lost, disconnected, dropped, misdirected or incomplete telephone calls. Entrants may be disqualified at the sole discretion of the Station.
- c. Only one qualifying entry per person per week for the **THREE WEEK** duration of the contest. The first week (10/1-10/5), second week (10/8-10/12) and third week (10/15-10/19) will each yield a separate pool of qualifiers and **ONE** Grand Prize winner, totaling **THREE** Grand Prize winners for the duration of the contest.

2. Eligibility Restrictions:

- a. The contest is open to all Station listeners who are legal United States citizens 5 years of age or older and who reside in the WOKQ listening area. Contest participants under the age of 18 must be accompanied by a parent or legal guardian at the event and must be represented accordingly on the registration form. Employees of Station, its licensee, Townsquare Media, their subsidiaries, affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations and the members of their immediate families are ineligible to participate or win. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household.
- b. Listeners are eligible to win a Station contest only once every thirty days, (though a "qualify" does not count as win). Only one winner per household is permitted in any contest.
- c. Participants in the Contest must possess a valid government issued photo identification.

3. Prizes:

- a. Each qualifier will receive a neon tee available for pick-up at the station at 292 Middle Rd in Dover ONLY during business hours (M-F 9a-5p). The first week (10/1-10/5), second week (10/8-10/12) and third week (10/15-10/19) will each yield a separate pool of qualifiers and ONE Grand Prize winner, totaling THREE Grand Prize winners for the duration of the contest. The Grand Prize will be a \$1000 gift certificate to Cardi's Furniture and Mattresses.
- b. All prizes or prize certificates may be picked up at the Stations' office located at 292 Middle Road in Dover, NH. Any prize or prize certificate not claimed within forty-five (45) days of winning will be automatically forfeited by the winner, unless a prize has an expiration date, in which case a prize may be forfeited earlier than forty-five days from winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its arrival. Station is not responsible for the safe arrival of a prize or prize certificate.
- c. Contest prizes are not transferable. Prizes may not be substituted or redeemed for cash.
- d. If applicable and required by law, the Grand Prize winner will receive a 1099 Misc Income IRS Tax form for the value of the grand prize as stated in these contest rules.
- e. Prizes are limited solely to those items explicitly set forth herein and shall not include any and all other expenses, incidentals or taxes that may arise out of the winner's receipt of this prize.
- f. Prizes will be awarded as is, with no written or express warranty.

4. Selection of Winners:

- a. Decisions of Station management with respect to the Contest are final.
- b. One winner will be chosen from the pool of applicants each week (at the station's discretion) for a total of three winners.
- c. Winner will be chosen at the conclusion of each week at 5pm on Friday and announced the followed Monday.
- g. The odds of winning are based on the number entries received.

5. Conditions:

- a. Photo identification and social security number of the Grand Prize winner may also be required in order to collect the prize. Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners will be required to sign an IRS Form W-9 or the equivalent. If applicable and required by law, the Winner will receive a 1099 Misc Income IRS Tax form for the value of the prize as stated in these Contest rules.
- b. Winner is required to sign a release in order receive the prize. Failure or refusal to execute the release will result in winner forfeiting the prize. Pursuant to the liability release, winners will agree to hold Station, its licensee, Townsquare Media, their subsidiaries, affiliated companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- c. By participating in the Contest, the winner or winners (and their guest or traveling companion, if applicable) agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest without additional financial or other compensation, and to sign a publicity release prior to acceptance of the prize.
- d. Station in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station website(s) or who is otherwise in violation of the rules. Station further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. Station reserves the right in its sole discretion to modify the Contest rules and dates at any time for any reason. Material modifications shall be announced on-air, when practical. By participating in this Contest, you agree to be bound by these Contest rules, any modifications thereof, and by all other rules imposed by Station management. If due to circumstances beyond the control of Station, any event associated with this Contest or the prize is delayed, rescheduled, postponed or cancelled, Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- f. No purchase is necessary. The Contest is void where prohibited.
- g. Failure to comply with the Contest rules may result in a contestant's disqualification, at the sole discretion of Station.

- h. Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest or in the announcement of a prize.
- i.
