Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.
A purchase or payment will not improve your odds of winning.

THE PROMOTION: The **[COUNTRY MEGABRACKET]** (the “Promotion”) will begin on **[FEBRUARY 21 2019 at 12:00AM EST]** and end on **[MARCH 15 2019 at 11:59PM EST]** (“Promotion Period”). Odds of winning depend upon the number of eligible Entries (as defined below) received. Promotion is subject to all applicable federal, state and local laws. Void where prohibited.

ELIGIBILITY: The Promotion is open only to legal United States (“U.S.”) residents of the FCC designated signal area of **[WOKQ]** (For designated signal area of **[WOKQ]** log on to **radio-locator.com**, enter **[WOKQ]** into the “Find US radio by call letters” box and the Coverage Map will be available to view) (“Designated Signal Area”) who are at least **eighteen (18)** years old as of the start of the Promotion Period. Void outside Designated Signal Area, in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions, and where prohibited by law. Officers, directors, and employees of Promotion Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Promotion. 4. BRACKETS MAY BE SUBMITTED THROUGH THAT FORM ONLY. ANY BRACKET SENT TO THE STATION IN ANY OTHER WAY/FORM WILL NOT BE ELIGIBLE.
5. ONCE BRACKET SUBMISSION PERIOD HAS CONCLUDED, WOKQ WILL LAUNCH VOTING FOR TWO WEEKS TO DECIDE WHICH COUNTRY ARTISTS ADVANCE IN THE BRACKET. WOKQ RESERVES THE RIGHT TO HAVE FINAL DISCRETION IN WHICH ARTISTS ADVANCE.

You may enter ONE TIME ONLY during the Promotion Period. WOKQ IS NOT RESPONSIBLE FOR ANY DIGITAL ERRORS INCLUDING CORRUPT/FAULTY FILES THAT CAN'T BE OPENED/READ. In the event that the selected caller is disconnected or is found to be ineligible by Sponsor in its sole discretion, the next eligible caller that successfully makes it through on the call-in line and completes their call and any on-air requirements as described above, as determined by Sponsor in its sole discretion, will be the potential winner (defined below). Entry constitutes permission (except where prohibited by law) to use entrant's name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval.

IF A WINNER CHOOSES TO HAVE THEIR PRIZE MAILED TO THEM, THEY ASSUME THE RISK. THE STATION OR SPONSOR- TUPELO MUSIC HALL- ARE NOT RESPONSIBLE FOR ANY LATE, LOST OR STOLEN MAIL.

All details of Prize will be determined by Sponsor in its sole discretion. Sponsor reserves the right to substitute a similar prize (or prize element) of comparable or greater value. Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned.
